While filling up the Proforma for **State Wise Preferences (SWP)** the following may invariably be kept in mind;-

i. The allocation to the Postal Accounts Office (PAO) would be with reference to the final rank obtained in the CGLE-2019 exam vis-a-vis preferences given and vacancies available, in the respective category. Due to rationalisation of JA post in PAOs, the final vacancy position is subject to change. Therefore candidates are advised to furnish all the 23 preference in the enclosed Proforma.

ii. The candidates must furnish the state wise/PAO wise preference in the proforma enclosed herewith. The preference should be made in the requisite box by writing the name of the PAO in BLOCK letters against the pro-forma box.

iii. The candidate must fill up all the preferences. All other details in SWP form i.e. Name, Roll No., Rank, Sign etc. should also be filled up correctly and completely.

iv. The allocation of the candidates eligible under PH category shall be made in accordance with reference to the rank obtained in the CGLE-2019 exam vis-avis preferences given and vacancies available in the respective category, as per the instructions contained in DoP&T OM dated 10<sup>th</sup> May 1990 and 13<sup>th</sup> March 2002.

v. The dossiers would be sent to the Postal Accounts Office, as per the preference filled up and existence of vacancies in the relevant category after completion of allocation process.

vi. The preferences will be strictly with reference to the rank obtained in the CGLE-2019 exam e.g. if two or more candidates of a category give preference for a particular state/PAO then priority would be given to the candidate with the higher rank and so on and so forth.

- ii. In case the candidate does not give any preference at all or the vacancies as per their preferences are not available, due to preference already made by the candidate having higher ranks or no vacancy existing in their respective category, in such scenario their dossier shall be liable to be sent to any of the Postal Accounts Office where vacancies exists.
- viii. The state wise preferences once given shall be final and cannot be altered/ changed at a later stage.
  - ix. In the event of multiple SWP received from a candidate via email/post and are different altogether, in such cases the SWP will be summarily rejected and the candidate's dossier will be liable to be sent to any of the Postal Accounts Office where vacancies exists.
  - X. The candidates, in whose case the SWP is not received by the due date, it shall be deemed as no preference have been furnished and their dossiers shall be liable to be sent to any of the Postal Accounts Office where the vacancies exists after allocation of candidates who have furnished the SWP.

Once again, it is reiterated that the ibid SWP must reach this office duly signed, either by **Speed post/Registered post or email (scanned image)** on the above given address **positively by 24<sup>th</sup> June, 2022**. The envelope containing the SWP may also be **super-scribed as PROFORMA FOR SWP-CGLE 2019.**
