- (b) Minimum working hour will be 16 hour per week as per directions of MS/Dean.
- (c) The Specialist shall be responsible for all cases under his supervision in his specialtydiscipline.
- (d) Available on call 24×7 if he/she submits his/her willingness for emergency duty at the time of joining
- (e) The Selected Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakh for Anesthesiologists, CardiacSurgeon,NeuroSurgeons,PlasticSurgeonsetc.(2)Rs.20lakhsforGeneralSurgeons, Gynecologist, Obstetrician etc. (3) for Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs. 10 lakhs. A copy of the Insurance & Premium and receipt must be submitted within 7 days from the date ofengagement.
