I. COMPANY PROFILE

The Shipping Corporation of India Ltd. (SCI) was incorporated in 1961, under the Companies Act 1956, by amalgamation of Eastern Shipping Corporation and Western Shipping Corporation with the objective to serve India's overseas and coastal seabornetrade as its primary flag carrier. It is an important player in the field of global maritime transportation, operates in almost all areas of shipping business catering to both national and international trades, including providing technical consultancy services. It has three major segments viz. Bulk carrier & Tankers, Liner Services and Technical & Managed Vessels Services, besides which it also mans and operates LNG vessels on behalf of its 4 Joint Ventures. It has recently forayed into inland waterways transport operating and managing IWAI's vessels through its wholly owned subsidiary Inland & Coastal Shipping Ltd.

Its Registered and Corporate offices are at Mumbai, Maharashtra.

The company employed 547 regular employees (Executive 495, Non-executive 52) as on 31.03.2022.

The authorized and paid up capital of the Company was Rs.1000 crores and Rs.465 crores respectively as on 31.03.2022.

The Government has given its 'in principle' approval for strategic disinvestment of Government of India shareholding of 63.75% in Shipping Corporation of India Limited along with transfer of management control to a strategic buyer.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Director (P&A) is a member of the Board of Directors and reports to Chairman & Managing Director. He/She is responsible for maintaining smooth industrial relations, administration and development of human resources of the Company. He/She should have the vision to develop and implement HR initiatives/strategies to meet committed business needs of the Company.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

3. QUALIFICATION:

The applicant should be a Graduate with good academic record from a recognized University/Institute.

Applicants with Post Graduate Diploma or Degree in Personnel Management/ Human Resources Management or Masters in Business Administration (MBA)/ Post Graduate Diploma/ Programme in Management (PGDM/PGPM) from a recognized University/ institution is desirable.

4. EXPERIENCE:

The applicant should have at least five years of cumulative experience during the last ten years in various aspects of HR/ Personnel Management/ Industrial Relations in an organisation of repute.

IV. DURATION OF APPOINTMENT

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
