Applications are invited for walk-in-interview for engagement of following contractual posts under the NAHEP project under ICAR.

Category – B : Senior Research Fellow (SRF) in Agriculture – 01 Nos.

Category – C : Young Professional-I (YP-I) in Finance & Accounts – 02 Nos.

Place of posting: Project Implementation Unit (PIU), National Agricultural Higher Education Project, Krishi Anusandhan Bhawan-II, Pusa, ICAR, New Delhi -110012.

1. Eligibility criteria:

A. Research Associate (Agriculture)

Essential: With Doctoral Degree: Ph.D in Agriculture & Allied Sciences OR

With Master's Degree: Master's degree in the Agriculture & Allied Sciences with 4 years / 5 years of Bachelor's degree having 1st division or 60% marks or equivalent overall grade point average, with at least three years of research experience as evidenced from Fellowship/ Associateship/ Training/ other engagements as circulated vide F.No. 2-9/2012-HRD dated 25.04.2014 and one research paper in Science Citation Index (SCI)NASS Rated (>4.0) Journal as per OM SR/S9/Z-09/2018 of DST dated 30.01.2019.

Desirable: Conversant with various computer applications (MS word, Excel, PowerPoint, Access, etc.), data organization/management/report preparation/writing, etc. Knowledge of procurement procedures will be an added advantage.

B. Senior Research Fellow (Agriculture)

Essential: Master degree in Agriculture and allied subject of Agriculture like (Agri. Economics/ Agri. Engg./ Agri. Extension./ Agri. Statistics/ Horticulture/ Agri Business etc.) circulated vide ICAR Circular No. F. No. Edn./6/27/2014/HRD dt. 09- 10-2015 and 13-10-2015.

Desirable: - Conversant with various computer applications (MS word, Excel, PowerPoint, Access, etc.), data organization/ data management and analysis/ proficiency in data analysis tools, technical report writing and statistical IT applications.

C. Young Professional-I (YP-I) (Finance & Accounts)

Essential: B. Com/BBA/BBS (With minimum 60 % marks) from a recognized University/ college with minimum 1 year of experience in relevant field.

Desirable: Knowledge of applications, virtual meeting platforms and computer skills (MS Word, Excel, PowerPoint, Tally, etc.) will be added advantage. Proficiency in typing in English/Hindi. Working knowledge of PFMS/FMS and GeM (E-Procurement System).

2. Emoluments:

Research Associate (RA)

Rs. 49,000/- per month plus applicable HRA (for Master Degree holders) & Rs. 54,000/- per month plus applicable HRA. (For Ph. D holders)

Senior Research Fellow (SRF)

- (i) For 1st and 2nd year: Rs. 31,000 per month + applicable HRA
- (ii) For 3rd year onwards: Rs. 35,000 per month +applicable HRA

The above emoluments are subject to eligibility as laid out in Office Memorandum F. No Ag.Edn./6/27/2014-HRD dated 30th July 2019, issued by Agricultural Education Division, Indian Council of Agricultural Research. Candidates not meeting these requirements will not be eligible for revised emoluments.

Young Professional-I (YP-I)

Revised consolidated emoluments of Young Professional (YP-I) will be Rs.25,000/- per month. No House Rent Allowance (HRA) will be paid to YP-I.

The above emoluments are subject to eligibility as laid out in Guidelines of OM F. No.Agril.Edn.1-06/2020-A&P dated 04th Dec, 2020 issued by Agricultural Education Division, Indian Council of Agricultural Research. Candidates not meeting these requirements will not be eligible for revised emoluments.

3. Age Limit:

Research Associate (RA)

Maximum 40 years for men and 45 years for women as on the date of interview. Relaxation for SC/ST/OBC/PH category candidates as per rules. Along with the application form, SC/ST/OBC/PH certificate (wherever applicable) duly attested is to be submitted.

Senior Research Fellow (SRF)

Upper Age Limit for SRF is 35 years on the date of interview (Relaxation for SC/ST/OBC/PH category candidates as per rules.). Along with the application form, SC/ST/OBC/PH certificate (wherever applicable) duly attested is to be submitted.

Young Professional-I (YP-I)

The minimum age under Young Professional (YP) category will be 21 years and maximum 45 years with relaxation for SC/ST/OBC/PH category candidates as per rules. Along with the application form, SC/ST/OBC/PH certificate (wherever applicable) duly attested is to be submitted.

4. Maximum duration of engagement of the RA/SRF/YP-I:

The period of appointment of RA/SRF will be initially for a period of one year and is likely to be extended further on yearly basis subject to satisfactory performance of the candidate. The initial engagement of YP-I will be for one year which is extendable for two more years subject to requirement of the services of YP in the organization and satisfactory performance of the candidate.

Further, the appointments will be co-terminus with the project.

5. Other Guidelines:

All other guidelines/provisions for RA/SRF shall be followed as in OM No. F. No Ag.Edn./6/27/2014-HRD dated 30th July 2019 and for YP-I shall be followed as in OM No.F. No.Agril.Edn.1-06/2020-A&P dated 04th Dec, 2020, issued by Agricultural Education Division, Indian Council of Agricultural Research.

7. Other Terms & Conditions:

- 1. The appointments will be on contractual basis and co-terminus with the project, and the incumbent shall not have any claim for regular appointment under ICAR or any further contractual engagements under NAHEP or ICAR.
- 2. The candidate must bring their all-original certificates/marksheets/testimonials etc. with one set of their self-attested copies from matriculation onwards and experience certificate in original (as applicable) with them.
- 3. Concealing of facts or canvassing in any form shall lead to disqualification of the candidature or termination even after appointment.
- 4. The period of appointment of RA/SRF/YP-I will be initially for a period of one year and is likely to be extended further on yearly basis subject to satisfactory performance of the candidate.
- 5. The appointments may be terminated at any time without notice or assigning any reason thereof. The RA/SRF/YP-I may also leave the assignment, on their own volition, by giving one month notice. At the end of the contract period, the candidate will have no right to claim any employment or engagement in the ICAR.
