- 3. The selected candidate will be appointed on deputation basis initially for a period of

three years which may be extended as per norms subject to satisfactory performance and other terms and conditions. The terms of deputation shall be regulated in accordance with the Department of Personnel and Training O.M.No.6/8/2009-Estt.(Pay-II) dated 17.06.2010 and O,M.No.2/6/2016-Estt(Pay-II) dated 17.02.2016, as amended from time to time.

- 4. The departmental officials in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the DRAT/DRTs under the jurisdiction of DRAT, Allahabad shall not be eligible for consideration for absorption or promotion.
- 5.
