I. COMPANY PROFILE

Bharat Dynamics Limited (BDL) was incorporated under the Indian Companies Act, 1956 with the objective of becoming self reliant and globally competitive in high technology aerospace industry. BDL is engaged in manufacturing of sophisticated state-of-art weapons systems for the Armed Forces. BDL is a Schedule "B" / Miniratna CPSE with the administrative jurisdiction of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate offices are at Hyderabad, Telangana.

The authorized and paid up share capital of the Company was Rs. 200 crores and Rs.183.28 crores respectively as on 31.03.2022.

The company employed 2658 regular employees (Executives: 820, Non-executives: 1838) as on 31.03.2022.

The shareholding of the Government of India in the company is 74.93% as on 31.03.2022.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Production) is a member of Board of Directors and reports to the Chairman and Managing Director. As a member of the top management group, he/she advises on all matters pertaining to production, productivity and technology.

III. ELIGIBILITY

The applicant should possess adequate technical/operational experience/exposure at a senior level of management in an organization of repute, out of which at least 5 years during the last 10 years should have been in Defence Sector/Missiles/Aerospace Projects.
