I. COMPANY PROFILE

Broadcast Engineering Consultants India Limited (BECIL), a Mini Ratna Central Public Sector Enterprise (CPSE) was incorporated on 24th March, 1995 under the Companies Act, 2013 (erstwhile the Companies Act, 1956) by Government of India with 100% equity share capital of BECIL held by President of India through Secretary and Joint Secretary of Ministry of Information & Broadcasting.

The Company was initially set up for providing project consultancy services and turnkey solutions encompassing the entire gamut of radio and television broadcast engineering, covering establishment of content production facilities and transmission facilities for terrestrial, satellite and cable broadcasting in India and abroad.

BECIL has its Head Office in New Delhi, corporate Office in Noida and regional Office in Bangalore and Kolkata. BECIL is exploring geographical expansion in many states due to diversification in business portfolios.

The company employed 69 regular employees (Executives: 56, Non-Executives: 13) as on 31.03.2022.

The authorized and paid up capital of the company was Rs. 2.5 Cr. and Rs. 1.365 Cr. respectively as on 31.03.2022.

The shareholding of the Government of India in the company is 100% on 31.03.2021.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Director (O&M) is a member of Board of Directors and reports to CMD. He/She is functionally and administratively responsible to CMD and the Board. He/She is responsible for overall control over technological aspects, project planning, designing and project execution in various fields.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant should have at least five years of cumulative experience/exposure in Operations/Marketing/Contract/Tech Consultancy during the last ten years at a senior level of management in a large organization of repute.

Experience in research, planning and in implementation of projects in the field of Broadcasting would have added advantage.
