VACANCY FOR THE POST OF DIRECTOR GENERAL, CLAWS

- 1. Vacancy for the post of **Director General** is available at the Centre for Land Warfare Studies **(CLAWS)**. CLAWS is an independent 'Think Tank' under the Indian Army.
 - (a) <u>Desirable Qualifications</u>. The appointment is for "Two years" contract, which can be renewed depending on the performance and mutual consent. The following are the desired qualifications:-
 - (i) Experience and knowledge of the current geo strategic situation and thinking on Land Warfare issues.
 - (ii) The Director General should be HC/HDMC and NDC qualified. Academic qualifications including Phd will be given preference.
 - (iii) Published work including books on Strategy and Land Warfare is desirable.
 - (iv) Experience of working in similar think tank(s)/institutions /organisations will be given preference.
 - (v) Age preferably below 68 years as on 01 December 2022 (maximum age to tenant the appointment will be 70 yrs).

(c) Charter of Duties.

- (i) Director General, CLAWS is the 'head of staff' appointed on a contractual basis and is responsible for Academic and Administrative functioning of CLAWS.
- (ii) Function under the overall directions of the Executive Council (EC) and the Board of Governors (BoG), CLAWS as regards the projects, priorities, other policy issues and routine functioning/ management of the Centre.
- (iii) Plan research and study subjects at CLAWS and assign responsibilities to Research Scholars.
- (iv) Plan and organise international, national and CLAWS seminars.
- (v) Conduct periodic events like lectures, panel discussions, seminars and brain-storming sessions.

- (vi) Publishing of 'CLAWS Journal' and 'Scholar Warrior' biannually and other seminar papers/journals.
- (vii) Conduct events outside Delhi after prior sanction of Chairman BoG/ President EC.
- (viii) Brainstorming sessions/ panel discussions/seminars can also be conducted at stations outside Delhi, where large number of serving Army officers are present / retired officers are settled, after prior sanction by President, EC.
- (ix) Be custodian of CLAWS funds on behalf of Chairman, BoG and exercise prudence in expenditure of CLAWS funds.
- (x) Act as Member Secretary of CLAWS BoG and EC.
- (xi) Develop linkages with other reputed institutions i.e. Think Tanks, Universities and Academia both at National and International levels.
- (xii) Ensure proper record of all decisions taken at the meeting of the BoG and EC.
- (xiii) Advise Chairman BoG/ President EC on all matters of administration and policy of CLAWS and implement BoG/ EC decisions.
- (xiv) Sign jointly with the Chairman of the BoG or other members on contracts, suits, documents and deeds pertaining to CLAWS.
- (xv) Sign, jointly with President of the EC, where necessary on contracts, suits, documents and deeds pertaining to CLAWS.
- (xvi) To provide directions and guidance to PROMEX.
