Duration	Duration of engagement shall be one semester to start, and may be extended on semester to semester as per institute policy. Maximum duration of appointment in the entire career of a person shall be limited to 05 semesters.	
Leave	Faculties engaged under this category shall be entitled for 18 days Casual Leave (CL) and 3 days Restricted Holiday (RH) in each calendar year and in case of appointment in the middle of year or in termination of service, calculation of eligibility for CL shall be made on proportional basis for full completed months. Any other leave would be Leave Without Pay (LWP).	
Other Benefits	Faculty shall be eligible for travelling allowance for attending conference/workshop/paper presentation as payable to the concerned equivalent regular post. Further, they shall also be eligible for Cumulative Professional Development Allowance (CPDA) in proportion to their period of engagement as payable to concerned equivalent regular post.
