## TERMS AND CONDITIONS FOR ENGAGEMENT OF DOCTORS PURELY ON CONTRACT BASIS IN CENTRAL GOVERNMENT HEALTH SCHEME, NAGPUR

- 1. Candidate must be a citizen of India.
- 2. The maximum age limit for contractual employment is 70 years. The candidate must not cross 70 years during the tenure of appointment of 01(One) year.
- 3. Candidate for contractual appointment for the post of GDMO/Specialist shall be retired from Central Govt./State Govt./PSU. Candidate should be a pensioner drawing pension from any of the above Govt. body or PSU.
- 4. The appointment is purely on contract basis initially for a period of one year or till a regular incumbent joins, whichever is earlier.
- 5. Education qualification:-
  - For Specialist:- PG Degree with three years service in the relevant field or PG diploma with five years service in the relevant field.
  - ii) For GDMO:- Minimum qualification required MBBS Degree.
- 6. Remuneration:
  - i)For Allopathic Specialist:- A consolidated amount of rupees 95,000/- per month.
  - ii) For GDMO:- A consolidated amount of rupees 75,000/- per month.
- 7. Extension of contract is subject to (i) Attending reasonable number of patients (ii) Good behaviour towards CGHS beneficiaries iii) performance report submitted by the incharge of wellness centre on monthly basis and as and when submitted iv) Regular attendance.
- 8. The Government also reserves the right to discontinue or terminate the contractual doctor on failure to perform duties to the satisfaction of the competent authority
- 9. The Government also reserves the right to discontinue or terminate the contractual doctor abruptly without assigning any reason at any point of time.
- 10. The remuneration will commence from the date of joining duty at the place of posting.
- 11. Though primary duty would be as a clinician but the engaged contractual doctor shall perform the duties assigned to him/her by Additional Director, CGHS, Nagpur. The competent authority reserves the right to assign any duty as and when required. No extra/ additional allowance will be admissible in case of such assignment.
- 12. The engaged contractual doctor shall not be entitled to any benefit like provident fund, pension, gratuity, medical attendance treatment, seniority, promotion etc. or any other benefit available to a Government servant, appointed on regular basis.
- 13. Dearness Allowance or any other allowance like HRA, TA etc. and other benefit like LTC, leave encashment are not admissible to the contractual doctor at any point of time.
- 14. Neither private practice of any kind is permissible nor any non-practicing allowance admissible in addition to monthly fixed remuneration.
- 15. The engaged contractual doctor will not have any claim or right for regular appointment to any post under Central Health Services.

- 16. The engaged contractual doctor working as contractual GDMO/Specialist in CGHS shall not accept any other appointment, assignment paid, part time or otherwise and shall not engage himself/herself in any kind of practice during the period of contract.
- 17. The appointment carries within the liability to serve anywhere under the administrative control of Additional Director, CGHS, Nagpur. It includes CGHS Nagpur as well as CGHS Raipur & CGHS, Chandrapur or any new centre if opened/relocated in future.
- 18. Candidate must be physically and medically fit .The engagement to the said post will be subject to production of Medical fitness certificate from competent authority.
- 19. The engaged GDMO/Specialist will be entitled for leave as per rules. Permission will not be granted to avail more than 07 days leave at a stretch.
- 20. On appointment, the engaged contractual doctor will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed Proforma.
- 21. The engaged contractual doctor is not entitled to any TA for expenditure made on application, for interview, for joining the contractual post or for any other purpose during the serving period.
- 22. Other conditions of service will be governed by relevant rules and orders issued from time to time.
- 23. If any declaration of given information furnished by him/her proves false or he/she is found to have willfully suppressed any material information, he/she will be liable for removal from his/her post as GDMO/Specialist (on purely contract basis) and also such other action as the government may deem necessary.
- 24. The list of short listed candidates and the date of interview shall be uploaded on the CGHS website <a href="www.cghs.gov.in">www.cghs.gov.in</a>. Candidates are requested to visit the website for update and corrigendum issued from time to time, if any.
- 25. Those doctors who are retiring from Central/State government or Public sector service within 06 months also can apply through proper channel.
- 26. Candidate retired from CGHS shall be given preference
- 27. Knowledge of computers is desirable
- 28. Doctor has to join his/her duty within 7 days positively. In case, selected candidate fails to join the duties on due date, offer shall be treated as cancelled and offer will be extended to next eligible candidate.
- 29. Interested candidates may apply in the prescribed application format in the website and submit the same along with the self-attested photo copies of all the requisite documents to the Office of the Additional Director, Central Govt. Health Scheme, Swasthya Bhawan, Near TV. Tower, Seminary Hills, Nagpur-440006 on or before 25.11.2022 upto 5:00 pm.
