OFFICE MEMORANDUM

Subject: Filling up one post of Deputy Director (Hydrometeorology) in the Hydrometeorology Cadre of Central Water Commission, Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti.

The undersigned is directed to say that one post of Deputy Director (Hydrometeorology), in the Hydrometeorology Cadre of Central Water Commission, Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti in Level 11 of the Pay Matrix (Rs 67700-208700), is to be filled up at New Delhi, by deputation from amongst officers of the Central Government or State Government or Union Territory administration or recognized Universities or Research Institutions or Public Sector Undertakings or Statutory or Autonomous organizations:

- (a) i) holding analogous post on regular basis in the parent cadre /Department; or
- ii) with five years' regular service in the posts in Level 10 in the Pay Matrix (Rs. 56100-177500) or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience, namely:-
- (i) Master's Degree in Physics or Geophysics or Geology or Meteorology or Hydrometeorology from a recognized University or institute with five years' experience in hydrometeorological work; or
- (ii) Bachelor's Degree in Physics or Geophysics or Geology or Meteorology or Hydrometeorology from a recognized University with seven years experience in hydrometeorological work.

Note 1: The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed four years.

Note 3: The maximum age limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

2. The said vacancy has been published in the Employment News dated 22.10.2022.

3. It is requested that the aforesaid vacancy may be circulated in your organization and applications of eligible and willing candidates may be forwarded in the enclosed proforma, along with attested copies of up-to date APAR dossiers for the last 5 years and Vigilance Clearance Certificates, to the undersigned latest by 21.12.2022.
