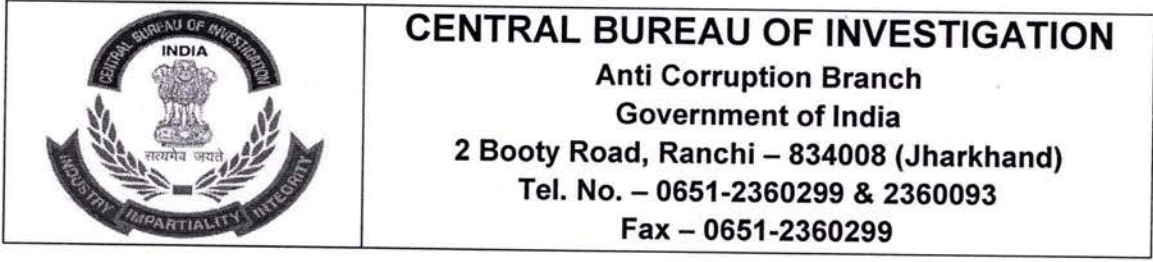

**TERMS AND CONDITIONS TOWARDS ENGAGEMENT OF CONSULTANT ON CONTRACT BASIS**

1. The candidate should be graduate from recognized university.
2. The retired Police Officers of the rank of Inspector and above of the Central/State Police Force with 10 years of experience in Investigation and Prosecution of Criminal/Anti-Corruption Cases in the Court of Law are eligible for appointment. The candidates will be on whole time appointment and will have no right to undertake part time private employment during the period of contract.
3. The maximum age limit of candidate is 65 years.
4. The person engaged shall have no right to claim regularization/absorption in the organization after the expiry of period of contract.
