## **I. DOCUMENTS TO CARRY:**

Candidates are required to fill the Application Form available in ECIL Careers web page and walk-in along with the following documents. Candidates will be allowed for Personal Interview only after successful document verification.

- Matriculation/10<sup>th</sup> Standard or equivalent certificate as proof of Date of Birth;
- Identity proof issued by Govt., like Aadhar, PAN, Driving License, Passport etc.;
- Qualification supporting documents & Internship Completion Certificate;
- Valid Registration Certificate with the respective State Medical Council.
- Service certificates related to the experience;
- Proof of Higher Qualification (if any);
- No Objection Certificate (NOC) from existing employer, in case the candidate is engaged in a State / Central Govt. Enterprises.

## **II. FINALIZATION OF MERIT LIST:**

- Candidates who qualify in the interview shall be empaneled in the Merit List.
- Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in qualification and interview.
- In case of a tie in the total marks scored between two or more candidates, then the candidate who scores more marks in interview shall be considered senior. In case there too the marks are equal then the candidate who is older in age shall be considered for issue of offer of appointment.
- Appointment of selected candidate will be subject to production of Medical Fitness Certificate as per extant rules of ECIL.
