2. Officials with flair for Income Tax Act, Smugglers & Foreign Exchange Manipulators (Forfeiture of Property) Act, Narcotic Drugs & Psychotropic Substances Act will be given preference.
3. The maximum age limit for appointment on deputation shall not exceed 56 years as on 01.02.2023.
4. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Government should ordinarily not exceed 3 (three) years.
5. The candidate selected will have the option either to draw their grade pay plus deputation duty allowances as per Rules or to have their pay fixed in the pay scale of the deputation post.
6. The above may kindly be given wide publicity amongst the eligible officials. The application of the eligible candidates in the prescribed pro-forma in duplicate along with their complete and up to date Confidential Character Roll dossiers for the last five years and who could be spared in the event of their selection may kindly be sent to this office latest by 31.01.2023.
7. While forwarding the application, it may be verified and certified that the particulars furnished by the applicants are correct and that no disciplinary case is pending or contemplated against the candidate concerned.
8. The persons selected for the post will not be allowed to withdraw their candidature subsequently.
9. Applications received after the last date or without complete and up to date APAR dossier or other-wise found incomplete will not be entertained.
