Experience:

The candidate with prior experience will be given preference. Previous service rendered(Indian Railways/State government other hospital/organization on regular/contract basis) may be indicated. However, other candidates without any experience can also apply.

2. Remuneration for Retired Government Medical Officer of Central/State Government;

Monthly remuneration will be paid by reducing his/her pension from Last Pay Drawn (i.e.Basic pay+DA) (Pay plus pension should not be more than the last pay drawn).

3. Place of working: As indiacted in the posting station column.

4. Qualification:

MBBS from a recognized University and musthave completed internship for one year and should be in possession of a vaid Registration Certificate of any of the State Council of India. In case of specialists they should have PG Qualification Diploma/Degree in the speciality from instituterecognized by Medical Council of India.

- a) Not exceeding 50 years as on date of notification ie 12.12.022 (05years age relaxation for SC/ST amd 03 years for OBC
- b) Not exceeding 65 years for retired IRHS officers/Retired Government Medical officers of State Government/Central Government.
- c) Reservation policy will be applicable as per extant rules.

6. How to apply:

7. Joining of the selected candidates:-

The selected candidates have to join immediately in the event of selection and after issue of letter

8. Terms & Conditions:

- 1. Depending upon administrative exigencies, Railway administraton reserve the right to modify number of vacancies and station of posting.
- 2. The CMP will not be allowed to do private practice.
- 3. No TA/DA/Taxi/Conveyance charge shall be paid for appearing for Walk-in-interview.
- 4. Engagement of doctors would be on contract basis initially for a period one year fromdate of appontment subject to further extension notification by Railway board for extension, or regular doctor report to join in division if any, as per administrative requirement on the basis of assessment of performance of CMPs or up-to attaining the age 65 years of age (in case of retired Govt. Medical Officers) whichever is earlier.
- 5. During the period of contract either party (CMP or Railway Administration) is free to terminate the contract on 15 days prior notice.
- 6. In case the medical Practitioner is found physically or mentally invalid or incapacitated the contract can be terminated forthwith.
- 7. Doctors engaged as CMPs shall not have any claim or right for his/her continuity in services or automatic extension of the terms of contract and shall not confer any right upon the selected candidate for filing any suit before any tribunal/court for extension and/or absorption in Railways.
- 8. After approval of panel by competent authority the panel will be uploaded at www.nr.indianrailways.gov.in and intimated through text message/email/whatsapp. Candidates who do not report on the assigned date and time will forfeit their chance of contract engagement and such opportunity will be offered to the next emplanelled candidates.
