#### **Educational Qualification:** 2.1

### 2.1.1 Graduate Apprentices:

- a) A degree in Engineering or Technology granted by a statutory University; OR
- b) A degree in Engineering or Technology granted by an Institution empowered to grant such degree by an Act of Parliament; OR
- c) Graduate Examination of professional bodies recognized by the Central Government as equivalent to a degree; OR
- d) A sandwich course student who is undergoing training in order that he may holder degree in engineering or technology as mentioned at (a) and (b) above.

### 2.1.2 Technician (Diploma) Apprentices:

- a) A Diploma in Engineering or Technology granted by a State Council Board of Technical Education established by a State Government OR
- b) A Diploma in Engineering or Technology granted by a University OR

- d) A sandwich course student who is undergoing training in order that he may hold a Diploma mentioned in (a), (b) and (c) above.
- 2.2 Only Fresh pass out students are eligible for apprenticeship training only up to 3 years after passing their degree/Diploma. Engineering Graduates or Diploma holders who had training or job experience for a period of one year or more after attaining the essential qualifications shall <u>NOT</u> be eligible for being engaged as an apprentice under the Act.
- 2.3 If the gap between the date of declaration of result and date of commencement of training is more than one year, an affidavit on stamp paper duly signed by Magistrate/Notary has to be submitted by the Apprentices, Mater of the affidavit will remain same as of declaration in the format given in Para 16.0 below.
- 3.0 Qualifying age: Not less than 14 years of age as on last date of submission of application i.e. 21 days from the date of last publication of advertisement in news paper/ddpdoo Portal/ NATS Portal.
- 4.0 Period of Training :- One year. Training shall be terminated after completion of one year.
- 5.0 This is purely a training course & thus any claim of employment after completion of training does not arise.
- 6.0 The selection can be cancelled at any time before or during the training of one year, if any document or information is found incorrect.
- 7.0 In complete application /application received after the due date will be automatically REJECTED & no complaints/representation will be entertained in this regard.

#### 11.0 Reservation:

As per Apprentices Act. Copy of Certificate from Competent issuing Authority is required to be submitted for obtaining Reservation. OBC candidates are required to submit Non-Creamy-Layer-Certificate (NCLC) valid as on closing date of receipt of application. Candidates not having valid certificate in respect of Reservation will be considered as unreserved candidate.

#### 12.0 Submission of application form:

- 13.0 Interested candidates may apply as per given Application Format (as per Annexure 'A') and condition mentioned above address to "The General Manager, Ordnance Factory Bhusawal, A Unit of Yantra India Ltd. Bhusawal, Pin-425 203, Maharashtra so as to reach this office within 21 days of publication of the advertisement in newspapers.
- 14.0 Application is to be forwarded in sealed envelope with title as "APPLICATION FOR THE POST OF GRADUATE/TECHNICIAN(DIPLOMA) APPRENTICE- (Group Code)" with self-attested photo copies of mark sheets of all semester caste certificate, Non- Creamy-Layer-Certificate (if applicable) and other required certificates.

### 15.0. Mode of Selection & joining process of the candidates:-

- Candidates will be selected only on merit, no interview or test will be taken for the selection and joining of the apprentices.
- ii) For preparation of merit list, in case of two candidates having the same marks/percentage (tie case), the candidates with older age shall be preferred. If the dates of birth are also the same then the candidates who passed Matriculation examination earlier (year) shall be considered first. Even if the year of passing of Matriculation examination is same, the candidate name in alphabetical order appearing first will be considered first.
- Wherever CGPA/OGPA/DGPA or Letter Grade in a degree/diploma is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University / Institute. Proof of norms adopted by the University/ Institute to convert CGPA/OGPA/DGPA into percentage is necessary to submit by the selected candidates at the time of verification of documents.
- iv) Merit list will be published on the notice board of Main Gate of OFBH and selected candidates will be called for the verification of documents.
- v) Candidates have to submit all desired documents during document verification. In case of failure to submit any of the desired documents, the candidate will not be permitted for document verification.
- vi) After verification of documents of selected candidates police verification will carried out.

- vii) Engagement of selected candidates will be subject to their passing the Medical Examination conducted by OFBH Hospital. It is mandatory for the selected candidates to register themselves on NATS Portal www.mhrdnats.gov.in and the same will be verified on the day of document verification. Selected candidates will not be allowed to join for training until the candidates complete the registration process on NATS Portal and generate their contract registration form on NATS Portal.
- No Hostel accommodation will be provided to the selected candidates by Ordnance Factory Bhusawal.
- ix) The duration of Apprenticeship training will be one year. If the candidate leaves the training midway, the stipend taken during the training period will have to be refunded to the candidate and he will have to write a security bond for the same.
