<b>Essential:</b>	A degree in Mechanical or Electrical Engineering of a recognized University or its equivalent.					
<b>Desirable:</b>	One year's Post-Graduate practical training or study or research or practical engineering experience.					
<b>AGE:</b>	Not more than 36 years on 01.01.2022, the age limit being relaxable, in the case of candidates who have been in the employment of the Central or the State Government or any Statutory Body recognized for the purpose by the Government and are not out of such employment for more than a year on the said date, to the extent of the actual period spent continuously in such employment. No relaxation of age-limit shall be allowed to a candidate who has already appeared in the examination thrice.					

**N.B. :** (i) Candidates will be selected on the basis of a competitive examination followed by interview, (ii) Provisionally eligible candidates would be called in for the written examination (M.C.Q. Type). Thereafter candidates qualifying in the written examination would be called to interview, (iii) The syllabus for the written examination will generally be in conformity with the educational standard/ technical qualifications as prescribed in the essential qualification. Details of the syllabus and date, time and venue of the written examination will be intimated to eligible candidates in due course, (iv) The Commission reserves the right for fixing qualifying marks in aggregate in respect of General, SC, ST, BC & PD candidates, (v) The final merit list will be prepared on the basis of marks obtained in written examination and interview taken together. (vi) No candidates will be allowed to take more than three chances. The departmental candidates shall be eligible to apply, provided they fulfill the requisite qualifications.

No claim for refund of the fee will be entertained nor will it be held in reserve for any other examination.

### **INFORMATION**

1. SUBMISSION OF MORE THAN ONE APPLICATION FOR THE POST BY THE SAME CANDIDATE IS STRICTLY FORBIDDEN AND SUCH APPLICATIONS ARE LIABLE TO CANCELLATION.
2. The qualifications prescribed in the advertisement are as per the notified recruitment rules issued by Government.
3. All the degrees/diplomas/certificates mentioned in the advertisement must have been obtained from Universities/Institutions, duly recognized by competent authority.

4. The Commission has fixed the following category wise qualifying marks in aggregate of marks obtained in Written Examination and Interview but there is no qualifying marks in the Interview.

The Commission will, however, have the liberty of further relaxing qualifying marks if any of the Reserved category posts remain unfilled owing to imposition of such qualifying marks, provided that in cases of absolutely incompetent candidates relaxation beyond a certain limit may not be allowed even if the posts have to be left vacant.

**Provisions regarding PWD candidates:**

Candidates having Benchmark Disabilities with limitation in writing including that of speed may be allowed the help of Scribe, if required. For convenience, P.W.D. candidates are requested to bring their own Scribe (wherever applicable). The Scribe should possess educational qualification one step below the qualification of the candidate taking examination. The person with Benchmark Disabilities opting for own scribe should submit details of the own scribe as per Proforma supplied by the Commission at the time of examination. In case of category of persons with Benchmark disabilities, the provisions of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the

Chief Medical Officer/Medical Superintendent of a Government health care institution as per Proforma at APPENDIX-I (Available at the end of this advertisement). The facility of Scribe would be allowed to any person with Benchmark Disability as defined under section 2(r) of the RPwD Act, 2016 and has limitation in writing including that of speed. In case persons with Benchmark Disabilities in the category of Blindness, Locomotor Disability (both arms affected - BA) and cerebral palsy, the facility of scribe shall be given, if so desired by the person. Engagement of scribe shall not be accepted after submission of the application (i.e. after closing date for Edit Window).

Candidates with benchmark disabilities having limitation in writing including that of speed and producing valid Appendix - I will be allowed compensatory time of 20 minutes per hour.

5. After display of Model Answers (MCQ Type) in the Commission's Website, objections by the Candidates need to be filed strictly within the specified time limit, beyond which no objection shall be entertained.
6. In cases where no Division/Class is awarded and only grading is done, exact percentage of marks and conversion formula adopted are to be mentioned with documentary evidence, if required.
7. Where experience of a number of years is prescribed as an item of qualification this would mean only experience/research experience gained in full time employment/research in the relevant field within the closing date of receipt of applications.  
[Certificate(s) from the Head(s) of the Organization(s)/Department(s) or Competent Authority for the entire experience claimed, clearly mentioning the duration of employment (date, month and year) and field of experience indicating basic pay and consolidated pay must be obtained. The certificate(s) should also mention the nature of duties performed/experience obtained in the post(s) with duration(s)].

8. Besides pay, the posts carry allowances as admissible.
9. The benefits of reservation of vacancies and upper age concession up to 5 years are admissible only to S.C. and S.T. candidates of West Bengal and up to 3 years to O.B.C. (category 'A' & 'B') (non creamy layer) candidates of West Bengal. S.C., S.T. and O.B.C. candidates of other States may apply for unreserved vacancies as general candidates. Such benefits are also available up to the age of 45 years for Persons with disabilities.

(a) A candidate claiming to be S.C., S.T., O.B.C. (non creamy layer) or persons with disabilities (40% and above) must have a certificate in support of his/her claim from a competent authority of West Bengal as specified below:

**For S.C., S.T. and O.B.C. (non creamy layer) candidates:**

(i) In the district, the Sub-Divisional Officer of the Sub-Division concerned, and

(ii) In Kolkata, the District Magistrate, South 24-Parganas or such Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas, on behalf and the District Welfare Officer, Kolkata and Ex-officio Joint Director, Backward Classes Welfare.

**For Persons with Disabilities:**

(b) The Public Service Commission may require such further proof of particulars from the candidates as it may consider necessary and may make enquiries about their character and other particulars regarding suitability and eligibility.

(c) S.C., S.T., O.B.C. (NON CREAMY LAYER) OR PERSON WITH DISABILITY CERTIFICATE MUST BE OBTAINED WITHIN THE CLOSING DATE OF RECEIPT OF APPLICATIONS AND NO CLAIM IN THIS REGARD WILL BE ENTERTAINED AFTERWARDS.

(d) O.B.C. (Non Creamy Layer) candidates must submit their renewed / revalidated O.B.C. (Non Creamy Layer) certificate prior to interview and at the time of appointment.

11. **All requisite certificates regarding educational qualifications, proof of age, other relevant experience certificates and other requisite documents must be furnished as and when required by the Commission.**
12. If at any stage even after issue of a letter of recommendation for appointment a candidate is found ineligible in terms of the advertisement his/her candidature will be cancelled without further reference to him/her.
