2. AGE LIMIT (Age as on 01.01.2023) :-


The candidate must have attained the age of 18 years and must not have attained the age of 30 years as on 01.01.2023 i.e must have been born not earlier than 02nd January 1993 and not later than 01.01.2005.

Note:- (i). The date of birth of candidates should be between the dates given above table (both days inclusive).

(ii). The candidate should also note that, once a Date of Birth has been claimed by them and

entered in the records of the Administration for the purpose of admission to the examination, no change will be allowed subsequently on any grounds whatsoever.

(iii) 10th/Matriculation Cerificate/Equivalent Educational Certificate/Educational Certificate mentioning date of Birth is mandatory for D.O.B (Date of Birth) otherwise application will be rejected.

- 12. Candidates recruited against cultural quota through open advertisement shall be terminated from service, if the information and documents furnished by them for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
- 13. Candidates those who are already in service of PSU/Govt Organizations and are eligible for the above should produce 'No Objection Certificate' for the same from their employer at the time of applying /trials.
