#### CIRCULAR

Sub: Filling up of the 01 (One) vacant posts in the grade of Chief Sanitary Superintendent in Dr. Ram Manohar Lohia Hospital, New Delhi by Deputation including short term contract).

01 posts of Chief sanitary Superintendent (Group 'B') Non-Gazetted, Non-Ministerial in the level-6 of Pay Matrix (pre-revised pay scale of Rs.35400 – 112400 with Grade Pay of Rs. 4200/-) is proposed to be filled in Dr. Ram Manohar Lohia Hospital by Deputation including short term contract). The eligibility for the post is given in Annexure-I. The period of deputation shall initially be for a period of one year but in any case shall not exceed 3 years. The pay of the selected candidate will be regulated in accordance with the orders of Govt. in force as amended from time to time.

It is requested that applications of suitable candidates who are eligible, willing and can be spared immediately, may be forwarded to the undersigned within a period of forty five days, in the prescribed pro-forma (Annexure-II) through concerned cadre controlling authority. The cadre controlling authorities should carefully check the applications and ensure that they satisfy the eligibility conditions before forwarding the same to this office. The application must be supported with the vigilance clearance and up to date ACR dossier.

Application with vigilance clearance, up to date latest 5 year ACR dossiers and last 10 years certificate that he/she has not been imposed any penalty.

- (i) Bachelor Degree in any discipline from any recognized University/Institute;

Diploma in Sanitary Inspector or Diploma in Health Inspector or Diploma in Sanitary Health Inspector.

(ii) Diploma in Sanitary Inspector or Diploma in Health Inspector or Diploma in Sanitary Health Inspector. (iii) 2 years experience in dealing with sanitation works in any recognized organization

Or

- **Note 1**: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
- **Note 2:**The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.
- **Note 3:** The maximum age-limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
