It is clarified that the candidates who had applied earlier in response to Advertisement **No. 29/2022** need not apply again as their previous applications will be considered, if they are found eligible. The eligibility of such candidates on account of age and educational qualifications etc. will be determined as on **06.12.2022** as per Advt. No. 29/2022.
