BHEL invites applications for **01 posts of either Sr. Associate Consultant or Consultant or a Senior Consultant** for BHEL Power Sector – Southern Region (Kudankulam Project Site). The position shall be based at Kudankulam, Tamil Nadu and shall report to Site Incharge/ Project Director, as applicable.

**Period of Engagement:**

The period of engagement shall be for 1 year which can be further extended by a period of upto one year at a time or till the completion of assignment (whichever is earlier). However, the maximum tenure shall be limited to five years or upto 65 years of age (whichever is earlier). Persons retired under VRS scheme will be considered only after they attain 60 years of age.

**Job Profile:**

The Consultant should assist and guide BHEL in the following areas:

- Providing expert advice & guidance to Management / Site execution team to provide complete solutions for handling and guiding in erection of major Equipments like Reactor Pressure Vessel-320 MT (RPV), Erection of Steam Generators – 307 MT(SG) (Unit#3-02 nos & Unit#4-04 nos), Reactor Coolant Pumps, pressurizer etc in reactor package.
- To coordinate and engage in technology qualification of Reactor main coolant piping welding of Unit #3&4.
- Providing guidance in establishing and preparation of specific procedures related to erection and welding of major Equipments of Nuclear reactor for Customer approval.
- Facilitating effective co-ordination with Customer and various execution agencies.

**Job Specifications:**

Any retired official (BHEL equivalent grade of E6A for Senior Associate Consultant/ E7 Level for Consultant / E8 for Senior Consultant level) from PSUs/ Autonomous Organizations / Central or State Government Members of National Level Professional Institutions or a Private Sector\* Organization meeting the following eligibility criteria can apply:

\*Private Sector mentioned above is a company where the annual turnover is Rs 10,000 Crs or more.(Average audited annual turnover of last 3 financial years

- Age (as on 01<sup>st</sup> April, 2023):** The applicant should be less than 64 years of age.
- Qualification:** Bachelor's Degree in any Engineering Discipline. Masters in Engineering is desirable.
- Experience: (as on 01<sup>st</sup> April, 2023)**
  - The applicant should have at least 20 years/ 22 years / 25 Years of work experience (for Sr. Associate Consultant/ Consultant/ Senior Consultant respectively) in Power Sector in the areas of Erection, Commissioning, Technical Services, Construction management, Troubleshooting and Project Quality functions.
  - Out of which at least 2-3 years of experience should be in handling erection of major Nuclear project Equipments like Reactor pressure vessel, Steam Generator, Reactor Coolant Pumps, Pressurizer etc in Reactor package.

**Selection Process:**

The applications, received against the advertisement, will be scrutinized by a committee and the shortlisted candidates may be then called for an interaction, if required, by a duly constituted Selection Board.

**Emoluments:**

Consolidated fees of a Sr. Associate Consultant (retired from BHEL equivalent grade of E6A) is Rs 80,000/- (Rupees Eighty Thousand only) and for Consultant (retired from BHEL equivalent grade of E7) is Rs 84,000/- (Rupees Eighty-Four Thousand only) and for Senior Consultant (retired from BHEL equivalent grade of E8 or above) is Rs 90,000/- (Rupees Ninety Thousand only).
