3. CRUCIAL DATE

Age & Post qualification Experience will be considered as on date of issue of Notification of employment as on date of Advertisement in the Company Website i.e., 10.04.2023.

4. AGE LIMIT

- i) Age Relaxation for OBC (Non-Creamy layer) for 3 years, for SC/ST 5 years, Ex-Servicemen candidates will be as per Government of India guidelines and the same will be extended only if valid OBC (Non-Creamy Layer)/SC/ST/Discharge Certificates are uploaded at the time of online application.
- ii) Wherever there is no reservation for OBC (Non-Creamy layer)/SC/ ST categories in a particular post, candidates belonging to OBC (Non-Creamy layer)/SC/ST categories applying against unreserved vacancies shall be considered under general standard of merit and no relaxation in age will be extended.

- iii) Relaxation for Ex-Servicemen (ESM) category candidates is as per extant Govt. of India guidelines.
- iv) Upper age limit indicated above does not apply to employees currently on the rolls of Nepa Limited. However, they should have minimum 02 years of remaining service as on crucial date i.e., publication of advertisement in the Company Advertisement i.e., 10.04.2023.

5. Period of Employment

- i) Selected Candidates for contractual positions will be initially engaged for a period of 1(one) year from the date of joining the post notified and the tenure will be extended maximum to three years (including the initial year) as per the requirement of the Company and discretion of the Competent Authority.

6. Place of Posting

Selected candidates are liable to be posted to any Unit/Area/Place under the control of Nepa Limited, Nepalnagar.

7. Method of Selection

- i) For the Contractual Positions selection will be based on written test/trade test/skill test/personal interview whichever any mode the screening committee deemed fit on the discretion of the competent authority.
- ii) The minimum qualifying marks in the personal interview shall be 50% of prescribed score for UR candidates and 40% in the case of SC/ST/OBC (Non Creamy Layer) candidates against the reserved posts. Relaxation in minimum qualifying marks shall not apply for SC/ST/OBC (NCL) candidates considered under UR category.
- iii) The final selection of candidates shall be in the order of merit based on the marks scored by the candidates in the Personal Interview, subject to scoring the minimum qualifying marks prescribed, ensuring due reservation.
- iv) In case of higher response for any particular post, management reserves the right to conduct Screening Test.

8. Medical Fitness

The finally selected candidate(s) being engaged for the post is required to undergo Medical examination by registered Medical Officer and produce Medical Certificate before joining the post for which he/she offered.

9. Remuneration

Remuneration will be fixed as indicated with an increase of 10% of 1st year in case tenure is extended. This is non-negotiable. Remuneration is inclusive of all.

10. General Conditions

- iii) All qualification should have been acquired from Indian Universities/ Institutes recognized by AICT or UGC or any other appropriate statutory authority in India.
- iv) Post Qualification experience relaxation may be considered for deserving Ex-servicemen maximum for 5 years
- v) Preference may be given to Ex-servicemen and officers from Military Engineering background.
- vi) Any vacancy earmarked for EWS cannot be filled up due to non-availability of suitable candidate(s) such vacancy shall not be carried forward to next recruitment year as backlog.
- vii) The ideal incumbent for the Supervisory/Managerial position should have proven track record of managing administration, production and operations DCS, De-inking & Power House activities of Paper Industries having adequate experience in relevant field :-

 - Experience in written communication and management skill programs.
 - Experience in administration and operations at senior level.
- viii) The ideal candidate should be B.E. or B.Tech./B.E. + MBA or B.Tech./ B.E. or CA/ICWA + MBA, Diploma should be in any of the streams viz. Mechanical/Electrical/Chemical/Civil/any core Engineering Branch. Other qualifying requirements being the same, preference to candidates shall be considered having better post qualification experience in relevant industry/field/similar positions.
- ix) Depending on the response and requirement, Nepa Limited Management reserves the right to raise/relax the eligibility conditions.
