5. PROCESS OF CERTIFICATION

- 5.1. Candidates seeking reservation benefits for ST/OBC (non-creamy layer)/EWS must ensure that they are entitled to such reservation as per eligibility and as notified by A&N Administration. They should also be in possession of valid certificates in support of their claim at the time of submitting the application form.
- 5.2. A person seeking appointment on the basis of reservation to OBCs must ensure that he/she possesses the caste/community certificate and does not fall in creamy layer on the crucial date. The crucial date for this purpose will be the closing date for receipt of applications, i.e., 30/05/2023. Certificate for the status of creamy layer issued between 01/06/2020 to 30/05/2023 only will be accepted.
- 5.3. Candidates may also note that their candidature will remain provisional until the veracity of the concerned certificates/documents relating to the Educational Qualifications, Caste/Category, etc. is verified and found satisfactory by the Appointing Authority. Candidates are cautioned that they will be debarred from the examinations conducted by the A&N Police Dept. in case they fraudulently claim the status of ST/OBC/EWS/ESM/Departmental candidates/PwD etc.
- 5.4. Crucial date for claim of ST/OBC/EWS status or any other benefit, viz., age-relaxation etc., where not specified otherwise, will be the closing date for receipt of online applications, i.e., 30/05/2023.

7.2. INDICATIVE SYLLABUS:-

- 1) **General Knowledge (General Awareness):** Questions in this paper shall include General Awareness as well as General intelligence and Reasoning ability. Questions shall be aimed at testing candidate's General Awareness of the environment around him/her and its application to society. Questions shall also be designed to test his/her knowledge of current events and of such matters of everyday observation and experience in their scientific aspect as may be expected of an educated person. The test shall also include questions relating to India and its neighbouring countries, especially pertaining to History, Culture, Geography, Indian Economy, General Polity, Indian Constitution, Scientific Research, etc.
 - 2) **General Aptitude (Logical Reasoning & Numerical Aptitude):** The questions in this subject shall consist of topics to check the candidate's abilities to resolve problems, reasoning-related calculations and any other topic to check the knowledge/command in this subject.
 - 3) **Computer Knowledge:** The questions in this subject shall consist of topics related to computer applications, terminologies, shortcuts, software, hardware or any other topic to check the knowledge of computers and its related fields.
 - 4) **हिन्दी:** The questions in this subject shall consist of topics related to Hindi language (history and varieties), Hindi grammar, vocabulary, syntax, standardization or any other topic to check the knowledge/command in Hindi language.
 - 5) **English:** The questions in this subject shall consist of Spot the Error, Fill in the Blanks, Synonyms/ Homonyms, Antonyms, Spellings/ Detecting mis-spelt words, Idioms & Phrases, One word substitution, Improvement of Sentences, Active/ Passive Voice of Verbs, Conversion into Direct/ Indirect narration, Shuffling of Sentence parts, Shuffling of Sentences in a passage, Cloze Passage, Comprehension Passage, or any other topic for checking the knowledge of English language.
 - 6) **Trade Related Technical Knowledge (Physics, Electronics, & Electrical) [for the post of Radio Operator (ASI), Radio Technician (ASI), & Cipher Operator (ASI)]:-** The question in this subject shall consist of questions to check the knowledge of subjects Physics, Electronics, & Electrical Engineering.
 - 7) **Forensic Chemistry and Toxicology [for the post of Senior Scientific Assistant]:-** Questions on Forensic Chemistry and Toxicology shall be based on the syllabus of Forensic Chemistry and Toxicology taught at Post Graduation level in various universities.
 - 8) **Forensic Biology [for the post of Scientific Assistant]:-** Questions on Forensic Biology shall be based on the syllabus of Forensic Biology taught at Graduation level in various universities.
 - 9) **Forensic Science [for the post of Senior Scientific Assistant and Scientific Assistant]:** Questions shall be from basics of Forensic Science, Law and knowledge of other scientific evidences other than Forensic Chemistry & Toxicology, & Forensic Biology.
- 7.3. Questions shall be of objective multiple choice type. Questions shall be set in Hindi and English except language concerned subjects i.e., English and Hindi that shall be set in the corresponding

languages only. The Trade related subjects or other field specific subjects shall be set in the English Language only.

- 7.4. **Negative Marking:-** There will be **0.25** negative marking for each wrong answer. No marking and no negative marking shall be awarded to unanswered questions. Candidates are, therefore, advised to keep this in mind while answering the questions.
- 7.5. **Qualifying Marks:-** The minimum qualifying marks is 40% of the aggregate total of marks obtained by the candidates in the written examination.
- 7.6. There shall be no provision for re-evaluation/re-checking of the scores. No correspondence in this regard shall be entertained.
- 7.7. Any change in the schedule of examinations will be informed to the candidates only through the website of A&N Police Department.
- 7.8. Visually handicapped (VH) candidates with visual disabilities of **forty percent (40%) and above and candidates suffering from Cerebral Palsy** can avail the assistance of a **SCRIBE** in the Written examination subject to such requests being made in the application form beforehand. Questions papers and Answer Sheets will not be provided in BRAILLE. No attendant will be allowed with visually handicapped (VH)/ Cerebral Palsy candidates inside the examination premises.

NOTE: Persons with Visual disability of less than forty percent (40%) will not be considered as visually handicapped persons. 13. **MEDICAL STANDARD [APPLYING FOR THE POST(S) OF A&N POLICE DEPT.]:-**

The candidates should be of sound state of health, free from defects, deformity or disease. Both eyes should have a vision 6/6 and 6/9 without any correction like wearing glasses or surgery of any kind to improve visual acuity. No relaxation is allowed to any category of candidates on this count. The candidates in the selection zone shall undergo Medical Examination by doctors in selected Government Hospitals in A&N Islands as per the prescribed standards in the Recruitment Rule.

“Appointment to the post shall be subject to successful verification of original documents related to educational qualification, age proof, category certificates (in case of OBC/ST/EWS etc.), Experience Certificate & other relevant documents, and successful completion of medical examination & Police verification.”

- 20.1. All candidates who register themselves in response to this advertisement by the closing date and time and whose applications are found to be in order and are provisionally accepted will be assigned Roll numbers and issued Admission Certificate (AC) for appearing in the Physical Measurement & Endurance Test.
- 20.2. Admission Certificates for examination will be issued online on the A&N Police website (<https://police.andaman.gov.in>) or <https://erecruitment.andaman.gov.in>. Candidates are advised to regularly visit the website of A&N Police Dept. (<https://police.andaman.gov.in>) for updates regarding the recruitment process.
- 20.3. For Police Posts only:- Physical Measurement & Endurance Test are mandatory but qualifying in nature.
- 20.4. Only those candidates who qualify in Physical Measurement & Endurance Test will be allowed to appear in Written Examination and/or Trade Test.

- 20.9. The option for post(s) based on the preference once exercised by the candidates will be treated as FINAL and IRREVERSIBLE. Subsequent request for change of Post by candidates shall not be entertained under any circumstances.
- 20.10. Candidates shall be considered for selection only to the posts which have been opted by them in their preference. If the candidate has not opted for a Post, he/she shall not be considered for selection to such post irrespective of his/her merit position. Therefore, candidates should exercise due diligence before giving their post-preferences.
- 20.11. Final selection and allocation of Post will be made on the basis of the performance of candidates in Written Examination/Trade Test/Typing Test (including bonus marks in case of NCC certificate) and the preference of Posts exercised by them.
- 20.12. Once the candidate has been allotted his/her first available preference, as per his/her merit, he/she will not be considered for any other post. Candidates are, therefore, advised to exercise preference of Posts very carefully.
- 20.13. At the time of various examinations, if a candidate is (or has been) found guilty of: (i) Using unfair means during the examination or (ii) impersonating or procuring impersonation by any person or (iii) misbehaving in the examination hall or (iv) resorting to any irregular or improper means in connection with his/her candidature for selection or (v) obtaining support for his/her

candidature by any unfair means, such a candidate may, in addition to rendering himself/herself liable to criminal prosecution, will also be liable:

- 1) to be disqualified from the examination for which he/she is a candidate
- 2) to be debarred, either permanently or for a specified period, from any examination or recruitment conducted by A&N Police.

22.3. USE OF MOBILE PHONES, PAGERS, CALCULATORS OR ANY SUCH DEVICES:

- 24.1. BEFORE APPLYING, CANDIDATES ARE ADVISED TO GO THROUGH THE INSTRUCTIONS GIVEN IN THE NOTICE OF EXAMINATION VERY **CAREFULLY**. THE NOTICE OF EXAMINATION IS PRINTED BOTH IN ENGLISH AND HINDI. IN CASE OF ANY DISPUTE, THE ENGLISH VERSION WILL PREVAIL.
- 24.2. CANDIDATES IN THEIR OWN INTEREST SHOULD SUBMIT ONLINE APPLICATIONS MUCH BEFORE THE CLOSING DATE AND NOT WAIT TILL THE LAST DATE TO AVOID THE POSSIBILITY OF DISCONNECTION/ INABILITY OR FAILURE TO LOGIN TO THE A&N POLICE WEBSITE ON ACCOUNT OF HEAVY LOAD ON THE WEBSITE NEARER TO THE CLOSING DAY.
- 24.3. A&N Police will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of examination and, therefore, candidature will be accepted only provisionally. The candidates are advised to go through the requirements of educational qualification, age, physical and medical standards etc. and satisfy themselves that they are eligible for the post(s). The certificates/documents in support of their Educational Qualifications, Category, etc. shall be sought at the time of Document Verification. Candidates may also note that they would be required to submit their certificates/documents of EQs/category, etc. as and when sought by the A&N Police Department or the Appointing Authority. After scrutiny of the certificates/documents of EQs/category, etc., if any claim made in the application is not substantiated by certificates/documents, the candidature of candidate will be cancelled.
- 24.4. Candidates seeking reservation benefits for Persons with Disabilities (PwD) must ensure that they are entitled to such reservation as per eligibility. - 24.11. The applicant to be selected to serve in the A&N Police department should have a good character and antecedents. Hence, candidates should disclose their involvement in criminal or any other cases, if any, against him/her, while submitting the application form. Candidature of such candidates shall be decided by the Screening Committee prior to the issue of selection list in accordance with the instructions laid down in the SOP vide No.3430 dated 10.07.2019 and the decision of the Screening Committee regarding acceptance or rejection of candidature of such candidates shall be final.
