5. Eligibility Criteria :-

- The candidate must be a permanent resident of Assam.
- The candidate must produce PRC issued in Assam for educational purpose/ Employment Exchange Registration certificate / Voter ID card of the candidate or his/her parents will be treated as proof of residency along with the online application form.

6. Education Qualification :-

Bachelor degree in commerce (B.Com) from any recognised University or Institute.

7. Preference:-

Preference shall be given to candidates having qualification of Intermediate in Chartered Accountancy (CA-Inter) or Chartered Accountant (CA) from the Institute of Chartered Accountants of India (ICAI).

8. Age:

The candidates should not be less than 21 years of age and not more than 38 years of age as on **01/01/2023**.
The upper age limit is relaxable :

- (i) By 5 years for SC/ST candidates, i.e. upto 43 years.
- (ii) By 3 years for OBC/MOBC candidates i.e. upto 41 years as per Govt. Notification No. ABP. 6/2016/9 dated Dispur the 25th April 2018.
- (iii) For Persons with Benchmark Disability (PwBD) by 10 years irrespective of SC/ST/OBC and General Category of candidate as per Govt. Memorandum No. ABP 180/2017/105 dated Dispur the 7th January, 2019.

Special provision regarding age relaxation for Ex-Servicemen:-

- (i) Upto 50(fifty) years for Open category.
- (ii) Upto 53(fifty three) years for Other Backward Classes or More Other backward Classes.
- (iii) Upto 55(fifty five) years for Schedule Caste or Schedule Tribes.

As per provisions laid down in the Assam Ex-Servicemen (Reservation of Posts in Grade-I and Grade-II in State Services) Rules, 2022.

The age limit of the candidates will be calculated on the basis of the **Matriculation /HSLC Admit Card or Pass Certificate** issued by a recognized Central/State Board/Council and no other document shall be accepted in lieu of the mentioned documents.
