No. CAU/Reg/213/AICRP/01(Pt.-II): Applications are invited in the prescribed form to fill various posts under AICRP and KVKs of Central Agricultural University, Imphal. The application form can be downloaded from the website www.cau.ac.in. The duly completed application form, along with prescribed fee of Rs. 1,000/- for UR/OBC candidates and no fee for SC/ST/PwBD/Women candidates, should be submitted online. Additionally, the hard copies of the downloaded filled-in application form, along with relevant documents, must be sent separately and must reach the office of the Registrar, Central Agricultural University, Imphal, on or before 25th July 2023. The payment of fee should be made through State Bank Collect SBI only (payment guidelines can be downloaded from the website www.cau.ac.in)

Terms and Conditions :-


1. Documents related with the information provided in the application form should be produced at the time of interview. Period of Ph.D. research work will not be counted as experience for the required minimum qualification.
2. Candidates already in service should submit their applications through proper channel. Candidates anticipating delay in sending their applications through proper channel, should prefer advance copy directly with required application fee. However, the candidate will have to produce **No Objection Certificate** at the time of interview, failing which he/she will not be allowed to appear in the interview.
3. Applications, which are incomplete/ not on the prescribed form/ received after the due date/ received without the prescribed application fee shall be summarily rejected. Separate application form and fee should be submitted for applying different posts and categories.
4. The University reserves the right to fill or not to fill up any post and also to increase or decrease the number of posts without assigning any reason thereon, and also reserves the right to withdraw the advertisement partially, or in full at any point of time by putting the notice on its website.
5. No interim correspondence shall be entertained.
6. Only shortlisted candidates based on their academic and career performance will be called for the interview.
7. For the posts of Scientist / equivalent and SMS, the maximum age limit is 35 years as on the last date of submission of application form. Age relaxation will be as per Govt. of India norms. (3 years for OBC, 5 years for SC/ST and 10 years for PwBD over and above the relaxation of 3 years for OBC and 5 years for SC/ST).
8. Employees working against Teaching/research Posts as contractual staff at Central Agricultural University, Imphal, will get as one time relaxation in upper age limit to a maximum of 5(five) years. The quantum of such age relaxation will also include broken period of service, provided one stretch of service is more than six months in an academic session.
9. Based on the merit, the candidates belonging to reserved categories (OBC/SC/ST/PwBD) are also eligible to be considered against the unreserved vacancies, if no relaxation in age has been availed by such reserve category candidates. If any concession in age is availed, such candidates will be eligible for consideration only against vacancies reserved for them in the respective discipline.
10. The age of superannuation for Sr. Scientist/Jr.Scientist/Scientist in AICRP and Sr Scientist-cum Head (KVK) under the control of Central Agricultural University, Imphal shall be governed by the rules of the University/ICAR as applicable to them and shall be *co-terminus* with the project. Other conditions of service will be governed by the relevant rules/regulations which may be issued by the University/ICAR from time to time. For SMS under KVKs, the age of superannuation is 60 years, their services shall also be *co-terminus* with the scheme.
11. The application form is available in the University website: www.cau.ac.in. Application form should be submitted on-line by giving prescribed fees. Final printed application format along with relevant documents must be sent as hard copy to the university by registered/speed post addressed to the **Registrar, Central Agricultural University, Lamphelpat, Imphal, Manipur- 795004**.

- 13 The service conditions of the appointee shall be governed in accordance with the rules of ICAR/University as applicable for AICRP/KVK, issued from time to time.
- 14 The University will not be responsible for any postal delay. Applications received after expiry of the last date will not be considered and entertained at all.
- 15 Candidates are advised to visit the University website: www.cau.ac.in, regularly for updates (Corrigendum or Addendum or cancellation to this advertisement).
- 16 Canvassing in any manner will lead to disqualification.
- 17 The University reserves the right to fix criteria for screening the applications so as to reduce the number of candidates to be called for interview.
- 18 Call letters to attend the interview will be sent to shortlisted candidates only by Email only. No correspondence will be made with the applicants who are not shortlisted / not called for the interview. Therefore, candidates are advised to check the University Website and their Email regularly.
- 19 The decision of the University in all matters relating to acceptance or rejection of an application, eligibility / suitability of the candidates, mode of selection, and criteria of selection, etc. will be final and binding on the candidates. No enquiry or correspondence will be entertained.
- 20 The following categories of persons shall not be eligible to apply for any position in the University:
 - (i) Who has been convicted by the Court of Law or any criminal proceedings are pending against him.
 - (ii) Who has entered into contracted marriage with a person having a spouse living.
 - (iii) Who, having a spouse living, has entered into or contracted a marriage with any person. Provided that the Competent Authority of the University may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party of the marriage, and there are other grounds for doing so, exempt any person from the operation of these rules.
 - (iv) Who is not a citizen of India, and
 - (v) Any other category of person disqualified for appointment by the Government of India from time to time.
- 21 All appointments made shall be provisional and subject to verification of certificates through proper channels. The University shall verify the documents and antecedents of the applicant at the time of appointment or anytime during the tenure of the service. In case, it is found at any point of time that any documents / information submitted by the candidate is false or the candidate has suppressed any relevant information, the services of the selected candidate shall be terminated forthwith without assigning any further reasons and without prejudice to such other action as may be taken under the provisions of Indian Penal Code for production of false information.
- 22 Candidates who have been awarded Ph.D. from foreign Universities should enclose "Equivalence Certificate" issued by the Association of Indian Universities, New Delhi, without which their candidature will not be considered and application will be rejected. However, persons who have acquired Ph.D. degree from Foreign University through nomination by MHRD's foreign scholarship programme will be exempted from the Equivalence Certificate.
- 23 All the qualifications and experience will be counted up to the last date of applications. Any additional qualification and experience acquired after the closing date will not be taken into account at the time of screening / selection.

- 24 In case of any inadvertent mistake at the time of process of selection, which may be detected at any stage even after issuing the appointment letter, the University reserves the right to modify / withdraw / cancel any communication made to the applicant.
- 25 In case of any dispute / ambiguity that may occur in the process of selection, the decision of the University shall be final.
- 26 A candidate belonging to any reserved category who desires to be considered for any unreserved post also besides the posts under reserved category, will submit separate forms for unreserved posts and reserved posts.
- 27 Any Candidate belonging to SC/ST/OBC/EWS etc., who wish to apply for any unreserved post, will not be given relaxation of marks if any, and of age, etc.
- 28 In case the applicant wants to claim benefits under the PwBD category, the applicant's relevant disability should not be less than 40 percent. Proof to this effect in the form of a valid Disability Certificate must be attached with the application.
- 29 The process of selection may be by a presentation / seminar / interview or a combination thereof.
- 30 Separate application (along with application fee) should be filled for each post applied for.
- 31 The University employees are covered under 'National Pension Scheme (NPS)' introduced by the Government of India.
- 32 Candidates shall have to produce original documents at the time of appearing in interview.
- 33 The appointment of a fresh candidate will be subject to verification. In case, the report of the police with regard to his / her conduct, character, antecedent, etc. is not found satisfactory, the provisional appointment shall be withdrawn / cancelled / terminated forthwith without notice.
- 34 Candidates are required to self assess in the application form as per the score card for the post applied.
- 35 Candidates are required to submit evidences for each of the information provided in the application form.
- 36 Candidate seeking age relaxation must submit the appropriate certificate of the competent authority prescribed under rule by the Govt. of India.
- 37 Candidate is liable to be transferred to any unit under the jurisdiction of Central Agricultural University.
- 38 The jurisdiction for all disputes/legal matter for this recruitment will be confined to the High Court of Manipur.
