The Delhi Metro Rail Corporation (DMRC) Ltd, a Joint Venture company with equal equity participation from the Govt. of India and the Govt. of the National Capital Territory of Delhi has been entrusted with the responsibility of implementation of the rail-based Mass Rapid Transit System, for Delhi. #### 2. AGE LIMIT AS ON 01/06/2023:

The age limit for candidates applying on Deputation basis shall be 55 years.

The age limit for candidates applying on PRCE basis shall be 62 years.

### 4. **SCREENING PROCESS:**

The selection methodology for candidates applying on <u>Deputation basis and PRCE basis</u> will comprise of **Personal Interview**.

#### 5. SCHEDULE OF SELECTION

I. Last date of receipt of duly filled in application (along with relevant documents) through Speed Post OR email is **16/06/2023.** Incomplete applications or applications received after the due date will be

- summarily rejected. DMRC shall not be responsible for loss/delay in post.
- II. The list of shortlisted candidates shall be uploaded on DMRC website in the Fourth (4<sup>th</sup>) week of June, 2023 (tentatively) and interview will be held in the Fifth (5<sup>th</sup>) week of June, 2023 at Metro Bhawan, Barakhamba Road, New Delhi OR through on-line mode (tentatively) (Complete details will be displayed on DMRC website).
- III. No separate communication, by post, will be sent to candidates individually. Candidates are required to go through the instructions / schedule for interview displayed on DMRC website and appear for the interview accordingly.
- IV. The final result shall be declared by 1<sup>st</sup> week of July (tentatively) on the website of DMRC.
- V. Eligible and willing candidates for the aforesaid post may apply as per the application format at **Annexure-I**. The candidate must enclose all relevant documents in support of their qualification, work experience, pay & pay scale.
- VI. The candidates presently employed in Govt. sector / Central Public Sector Undertaking (CPSUs) should send their application through proper channel along with Vigilance and D&AR clearance, so as to reach the below mentioned address within the stipulated time. All candidates are required to submit copies of their APARs for the last five years.
- VII.
