REQUIREMENT OF EXECUTIVES FOR DMRC MUMBAI PROJECT, ON DEPUTATION / POST RETIREMENT CONTRACTUAL ENGAGEMENT (PRCE) BASIS

The Delhi Metro Rail Corporation (DMRC) Ltd, a Joint Venture company with equal equity participation from the Govt. of India and the Govt. of the National Capital Territory of Delhi has been entrusted with the responsibility of implementation of the rail-based Mass Rapid Transit System, for Delhi. The Delhi Metro Rail Corporation, the Lifeline of Delhi, prides itself on its ability to nurture its employees through its unique work culture. Today, DMRC empowered by about 14,500 employees, with MRTS activities spread over Delhi-NCR, Mumbai, Patna etc., carry about 3 million passengers per day in Delhi & NCR. In addition to the above, DMRC is involved in providing consultancy services to a number of cities within India and abroad.

To meet the immediate requirement of personnel for Operation and Maintenance work of Mumbai Metro Line – 3 (Aqua Line), applications are, hereby, invited from working in, or, retired (in case of Post Retirement contractual engagement basis), experienced, dynamic and motivated persons of Indian nationality, from the Indian Railways/ CPSUs, for filling up the following categories of Executive posts in DMRC, on Deputation / Post Retirement Contractual Engagement (PRCE) Basis:

2. WORK EXPERIENCE CRITERIA AS ON 01.06.2023:

A.) For the post of Sr. Manager:

Candidate presently working in or retired (in case of application on Post Retirement contractual engagement basis) from Level-11 (Rs. 67700-208700/-) or, higher, in CDA pay scale, or, Rs. 60000-180000/- or higher, in IDA pay scale, with **minimum 15 (Fifteen) years** of professional experience in MRTS in respective system, in the Indian Railways/ CPSUs.

B.) For the post of Manager:

Candidate presently working in or retired (in case of application on Post Retirement contractual engagement basis) from Level-11 (Rs. 67700-208700/-), or, higher, in CDA pay scale or Rs. 60000-180000/- or higher, in IDA pay scale, with **minimum 08 (Eight) years** of professional experience in MRTS in respective system, in the Indian Railways/ CPSUs.

3. CUT OFF DATE AND AGE LIMIT AS ON 01.06.2023:

The age limit for candidates applying on Deputation basis shall be 55 years. The age limit for candidates applying on PRCE basis shall be upto 62 years.

4. PAY AND EMOLUMENTS:

- i. <u>For candidates selected on Deputation basis:</u> The selected candidate shall continue to draw parent department pay plus deputation allowance, as applicable, under the Govt. of India rules.
- ii. <u>For candidates selected on PRCE basis:</u> The selected candidate shall be eligible for the consolidated fee @ Rs. 96,600/- per month, for the said post. The consolidated fee for candidates working in/ retired, at/ from a higher Grade, will be restricted to the emoluments, as mentioned above. The substantive status of the candidate shall be considered.

5. SCREENING PROCESS:

The selection methodology for candidates applying on <u>Deputation basis and PRCE basis</u> will comprise of **Personal Interview**.

The selection process would judge different facets of knowledge, skills, comprehension, aptitude and physical fitness. All related information shall be available only on Website: https://www.delhimetrorail.com and candidates must regularly check the website for updates.

6. SCHEDULE OF SELECTION

- I. Last date of receipt of duly filled in application (along with relevant documents) through Speed Post OR email is 16/06/2023. Incomplete applications or applications received after the due date will be summarily rejected. DMRC shall not be responsible for loss/delay in post.
- II. The list of shortlisted candidates shall be uploaded on DMRC website in the Fourth week of June, 2023 (tentatively) and interview will be held in the Fifth week of June, 2023 at Metro Bhawan, Barakhamba Road, New Delhi OR through on-line mode (tentatively) (Complete details will be displayed on DMRC website).

- III. No separate communication, by post, will be sent to candidates individually. Candidates are required to go through the instructions / schedule for interview displayed on DMRC website and appear for the interview accordingly, along with original copies of testimonials.
- IV. The final result shall be declared by First week of July'2023. (Tentatively)

Eligible and willing candidates for the aforesaid post may apply as per the application format at **Annexure-I**. The candidate must enclose all relevant documents in support of their qualification, work experience, pay & pay scale.

The candidates presently employed in Govt. sector / Central Public Sector Undertaking (CPSUs) should send their application through proper channel along with Vigilance and D&AR clearance, so as to reach the below mentioned address within the stipulated time. All candidates are required to submit copies of their APARs for the last five years.
