Subject:- Engagement of retired Central Government Officers at the level of PSO/Sr.PPS/ PPS/PS/Steno-Grade C as Consultant in National Recruitment Agency on contract basis.

The National Recruitment Agency (NRA) invites applications from retired Central Government Officers for engaging them as Consultant in the NRA HQ at 4<sup>th</sup> Floor, Tower-II, Jeevan Bharati Building, Connaught Place, New Delhi-110001 at the level of PSO/Sr.PPS/PPS/Stenographer(Grade-C). The number of Consultants to be engaged are tentatively 04 and the same may be increased or decreased as per requirement of NRA and suitability of candidates. The remuneration of Consultants will be as per extant Rules and instructions of the Government of India.

- 2. The candidates must have retired as PSO/Sr.PPS/PS/Steno(Grade-C) and must have experience in working with senior officers of Central Government or Autonomous Organisation or Central Public Sector Enterprises or Universities or Judicial Institutions etc. The Consultant should have working knowledge of MS Office Computer handling & Internet browsing, age not exceeding 65 years as on closing date for receipt of applications. However, in the deserving cases age can be relaxed upto 70 years.
  - 3. <u>Method of Selection:</u> The engagement will be purely on contract basis. Shortlisted candidates would be engaged as Consultants as per the requirement of the NRA.
  - 4. The terms and conditions of their appointment will be as follows: -
  - (a) The term of appointment shall ordinarily be for an initial period not exceeding one (1) year, which is extendable up to two (2) years as per requirement of NRA or till the time regular officers/officials join NRA on deputation basis.
  - (b) The consultant shall maintain integrity and confidentiality with the Government of India and would be required to sign a non-disclosure undertaking as per Annexure-I.

- (c) In terms of Department of Expenditure OM No.3-25/2020-E IIIA dated 09.12.2020, a fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the terms of the contract. No increment and Dearness Allowance shall be allowed during the term of the contract.
- (d) The Income Tax or any other tax will be deducted at source as per the Government instructions. Necessary TDS Certificate will be issued to them.
- (e) They shall not be entitled for perquisite such as HRA, CCA, residential accommodation etc. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the consultant at the time of retirement.
- (f) No TA/DA would be admissible to them for joining the assignment or on its completion.
- (g) During the period of consultancy, the consultants would be required to attend to all important items of work pertaining to NRA as assigned from time to time.
- (h) During the period of their assignment with the NRA and also thereafter, it is likely that they may come across certain information of important/confidential nature. They will not divulge any information gathered by them during the period of their assignment to anyone who is not authorised to know/have the same.
- (i) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of consultancy. Accumulation of leave beyond a calendar year will not be allowed.
- (j) The Consultant shall be required to observe the normal office timings and may also be called upon to attend the office on Saturday/Sunday/closed holidays/beyond working hours in case of exigencies of work.
- 5. <u>How to apply:</u> Willing retired Officers are required to send their applications in the prescribed format (complete in all respects) along with the requisite document i.e copy of PPO by 15<sup>th</sup> June, 2023 through e-mail to <u>diradmn-nra@gov.in</u>. Applications without duly filled in the prescribed proforma (Annexure-I) and without copy of PPO will not be considered for short listing.
