- 3. Age-Limit: Age should be below 61 years as on closing date of receipt of application.
- 4. **Period of Consultation**: Initially for two years period. The contract period may be extended further on need to FCI basis.
- 5. **Remuneration and Emoluments**: The appointee will draw lumpsum amount equivalent to basic pay, as he/she was drawing at the time of superannuation, which will be reduced by basic pension drawn by him/her, in case of officers superannuated from Government sector in CDA pattern or fixed remuneration of Rs. 60,000/-per month, in case the officer superannuated from CPSE with IDA pay scales.
- 6. **Tax Deduction at source(TDS):** TDS as admissible shall be deducted from the monthly remuneration of Consultant. A TDS Certificate shall be issued by the Bills Section on demand.
- 7. **Roles and responsibilities**: He/she would be engaged for providing services in Project Monitoring Units for monitoring silos projects in Food Corporation of India
- 8. **Method of selection**: Candidates meeting the above mentioned conditions shall be shortlisted. The shortlisted candidates will be invited for personal talk/ interview by a Committee constituted for this purpose whose decision will be final and no correspondence in this regard will be entertained. Intimation shall be sent only to the selected candidate.
- 9. Terms and conditions:
- I. The engagement as consultant on contract basis will be made initially for two years to those who have superannuated from CENTRAL GOVERNMENT / STATE GOVERNMENT / PSUs.
- II. The contract period of the superannuated officer may be extended further on need to FCI basis. The place of posting will be Delhi. The working hours will be from 0930 hrs to 1800 hrs on all week days (Monday to Friday) except holidays.
- III. The appointee should be free from vigilance angle and shall furnish vigilance clearance certificate from the last office attended.
- IV. The appointee shall sign an agreement of confidentiality with the FCI containing a clause on Ethics and Integrity. (Annexure-II)
- V. The appointee shall perform the duties assigned to him/her. The competent authority reserves

- the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
- VI. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc. or any other benefits available to the Government / FCI employees, appointed on regular basis.
- VII. The appointee will not have any claim or right for regular appointment to any post.
- VIII. The appointee will draw lump sum amount equivalent to basic pay, as he was drawing at the time of superannuation, which will be reduced by basic pension drawn by him/her, in case of Officers superannuated from Government sector in CDA pattern or fixed remuneration of Rs. 60,000/-per month, in case the Officer superannuated from CPSE with IDA pay scales.
- IX. No Dearness Allowance, increment, HRA and other allowances as admissible to the Central Govt. /State Govt. / PSUs servants, shall be admissible.
- X. Transport Allowance: An appropriate and fixed amount as Transport Allowance for the purpose of commuting between residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, the appointee may be allowed TA/DA on official tour, if any, as per the entitlement of the post of Deputy General Manager of Food Corporation of India at the time of retirement.

Any other action as deemed necessary by the Corporation may be taken against the appointee.
