3. No Objection Certificate: Those who are working in Central/State Government/Semi Government/Autonomous body have to submit "No Objection Certificate" from their respective organization at the time of interview, failing which the candidature may be rejected.

4. Age Limit: Age limit refers to completed age in years as on last date of submission of application i.e. the date of walk-in-interview.

Upper Age Limit: 35 years.

5. Reservation: As per Government of India rules.

6. Place of Interview: The interview will be held at venue of AIIMS, Gorakhpur No TA/DA will be paid for appearing in the interview.

7. Short Listing: After scrutiny/verification of the documents as per eligibility criteria/ conditions, only eligible candidates may appear before the selection committee for interview. Candidates who report for walk-in- interview must bring printed copy of the application form, No Objection Certificate from the current employer (for govt. employees only) and produce all relevant original documents in proof of details furnished in their application at the time of interview.

TERMS & CONDITIONS

1. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.
2. Canvassing of any kind will lead to disqualification.
3. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
4. Private practice of any type is prohibited.
5. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS.
6. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.

The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
9. Leave entitlement of the appointee shall be governed as per the existing rules of the Institute.
10. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS.
