- (b) Possessing educational qualification and experience as under :-
 - (i) Degree or Equivalent from a recognized University or equivalent with English and Hindi as compulsory or elective subject.
 - (ii) three years experience in proof reading from an authorised Printing Press or Newspaper office and knowledge of printing work.
 - (iii) must possess medical category SHAPE-1
- 3. The period of deputation including ex-cadre post held immediately preceding this appointment in some other organization or departments shall ordinarily not exceed three years.
- 4. The terms and conditions of deputation will be governed by the standard terms and conditions of deputations as laid down in the Ministry of Personnel Grievances and pensions (Department of Personnel and Training) OM No.6/8/2009-Estt (pay-II) dated 17th June 2010 and as amended from time to time.
