Instructions to candidates

How to apply:-

Interested candidates may apply in the prescribed form (Annexure-A) by hand or by speed/regd. post along with copy of documents listed below. The candidate shall bring the following documents (in original) with them on the date of interview.

1. Two recent Passport size photographs.
2. Two sets of self-attested photocopies of the following documents:
 - a) Proof of Date of Birth.
 - b) SSC / 10th standard Certificate or equivalent.
 - c) Certificates in support of Educational qualifications.
 - d) Registration certificate with the concerned Medical Council / State Government Registration.
 - e) Caste/Category Certificate (If applicable)
 - f) Experience Certificate

Terms & Conditions:-

1. The appointment will be on contractual basis as follows:-

For FTS – One year on contract or till regular incumbent joins, whichever is earlier. The contract will be extendable for a further period of 02 (Two) more years based on satisfactory performance.

For PTS- One year on contract from the date of joining or till regular incumbent joins, whichever is earlier.
2. The engagement can also be short closed before one year if the performance is not found satisfactory or if the vacancy ceases to exist.
3. The selected Specialist must have a professional indemnity policy which should cover the period of contract. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services, the minimum sum assured per annum should be :-
 - I. Rupees 30 Lakhs for Anaesthesiologist, Cardiac Surgeons, Neuro Surgeons, Plastic Surgeons etc.
 - II. Rupees 20 Lakhs for General Surgery, General Surgeons, Gynaecologists, Obstetricians etc.
 - III. Rupees 10 Lakhs for general Physicians (Medicine, Dermatologist and Paediatric), Radiology and Pathology.

The copy of the insurance and premium received must be submitted at the time of signing of the agreement.

4. Consolidated remuneration:-

Full Time Specialist : Rs 1,00,000/- (Rupees One Lakh) only per month.

Part Time Specialist :- Rs 60,000/- (Rupees Sixty Thousand) only per month.

Charges for Emergency visit, (if willing) : Rs 15,000/- monthly as and when required.

Additional Remuneration beyond 16 hours / week: RS 800/- for every additional hour.

Additional hours of work is to be justified by Medical Superintendent.

5. Day and timing of duty:-

1) **Full Time Specialist:**


Working hours: 09.00 AM to 04.00 PM on week days and 09.00 AM to 01.00 PM on Saturdays. Should make emergency visit as and when it is required.

2) **Part Time Specialist:**

Working hours: 04 hours a day for 04 days in a week.

6. Vacancies are likely to be changed depending upon actual requirement at the time interview. In the event of joining of regular specialists, the interview for the concerned vacancies may be cancelled.
7. Full Time Specialists will be entitled for leave @ 04 days for each month of work on pro-rata basis.
8. Part Time Specialists will not be entitled to any kind of leave.
9. Full Time Specialists will be available on call 24*7 and Part Time Specialists will be available on call 24*7 those who are contracted for emergency duty.
10. The Specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.
11. No TA/DA will be paid to candidates for appearing in the interview.
12. The Medical Superintendent reserves the right to fill up all or any of the vacancy / post.
13. The Medical Superintendent reserves the right to alter the date or cancel the interview without assigning any reason thereof.

14. The selected candidates shall have to join duty immediately or the date indicated in the offer of appointment.
15. Private practices of any kind will not be allowed for full time contractual engagements.
