**Age:** Maximum 37 years as on 01.02.2024.

**General Conditions:**

2. Canvassing in any form will be a disqualification.
3. Candidates are requested to bring all their certificates in original along with attested copies to prove age, Qualification, Mark sheets / Experience certificates / latest salary certificate with break-up / Aadhar / PAN / Latest passport size photograph etc for verification, which has to be produced at the time of verification of certificates. Failure to produce the above certificates in original will disqualify from appearing for the selection test.
