\* Initially only EWS applicants will be considered for the vacancies earmarked for EWS category. However, in case any EWS vacancy remains unfilled due to non-availability of a suitable candidate belonging to EWS or otherwise, such vacancies may be filled by UR category. Hence eligible applicants from other categories are allowed to provisionally appear for interview against the posts earmarked for EWS subject to the conditions that: (i) their candidature will be considered only if a suitable candidate from EWS category is not available or the vacancy is otherwise not filled and (ii) their candidature will be as UR candidates and hence there shall be no relaxations otherwise permitted under specific categories, i.e. SC, ST or OBC.

Applicants fulfilling the eligibility criteria shall report for Walk-In interview as per the schedule given below with his/her duly filled in application in the prescribed proforma (as listed in annexure) available on JIPMER website appending therewith self-attested certificates and all other relevant documents for verification on the day of interview.

The persons belonging to **SC/ST/OBC/EWSs/PwBD** must submit the certificate in the requisite proforma duly issued by the authority concerned (*if applicable*).

- **OBC (NCL) Certificate issued by the competent authority during the current financial year i.e., between 1.4.2023 and 31.3.2024 will be considered as VALID CERTIFICATE**
- **INCOME & ASSET certificate to be produced by Economically Weaker Sections (EWSs) should be valid for the year 2023-24.**

  - *The applicants should mention only those teaching experiences which are recognized by MCI/NMC/DCI/recognized teaching institutions, wherever applicable, and after obtaining the requisite educational qualification for the applied post.*

- h) No Objection Certificate (*If applicable*)
- i) Any other relevant documents

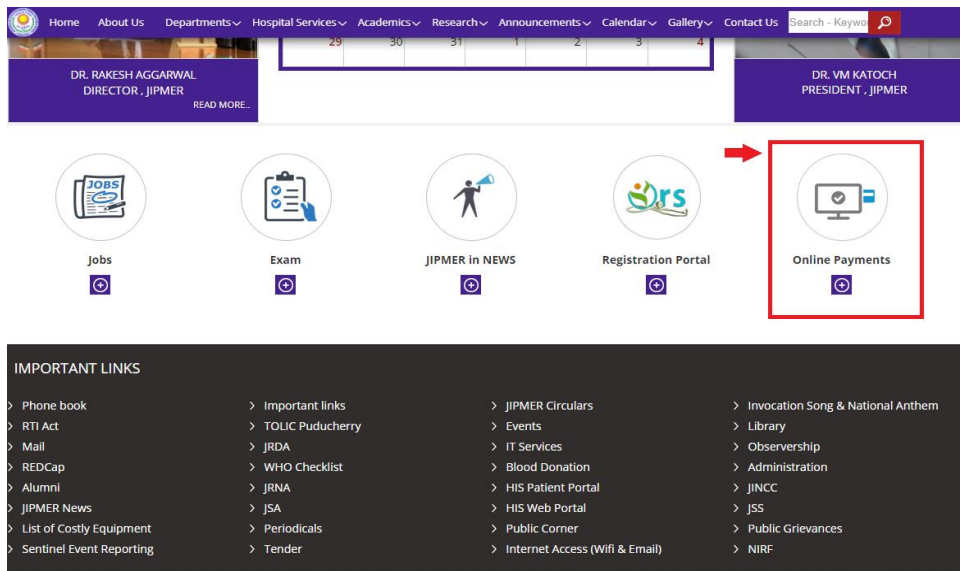
1. The candidates are strictly advised to read the detailed advertisement and confirm themselves whether they fulfill the required educational qualification, experience, age etc. for the respective post.
2. Experience will be considered only after obtaining the essential qualification.
3. **Applicants with incomplete certificates/documents will not be permitted for interview.**
4. It may be noted that determination of eligibility for appearing the interview is purely provisional. If at any subsequent stage during verification of certificates/documents or the selection process, it is found that a candidate has provided wrong information or otherwise does not possess the required essential qualifications or experience as per the Recruitment Rules of the post(s), he/she will be treated/declared as ineligible, and his/her candidature will be treated as cancelled. The decision of the competent authority in this regard will be final.
5. Applicants merely attend the verification of document on the day of interview does not possess any rights for selection.
6. **The decision of the competent authority is final in all regards.**

## TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT

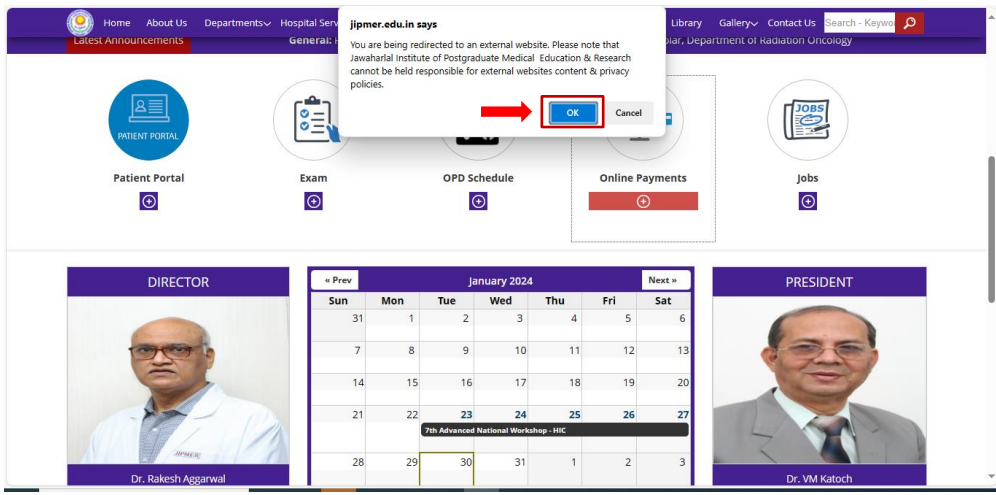
1. The appointment is purely on CONTRACT BASIS and will be initially for a period of 11 months with effect from the date of joining and extension will be granted for further period, if it is required by the administration. If the contract is not extended further, the same will lapse automatically.
2. The appointment can be terminated at any time before the expiry of contract period referred to above, with one month's notice without assigning any reason or if the person's work is considered unsatisfactory by the competent authority.
3. If the appointee wishes to resign his/her job, he/she has to serve one month's notice or remit one month's salary or pay thereof, as the case may be proportionate to the shortfall in the notice period.
4. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
5. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion, Allowances etc. or any other benefits available to the regular employees of this Institute.
6. The appointee shall not be granted any claim or right for regular appointment to any post of JIPMER Puducherry/JIPMER Karaikal.
7. The appointee shall be on a whole time appointment at JIPMER, Puducherry, and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
8. The appointment to the said post will be subject to medical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority.
9. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
10. The appointee will not be entitled to any T.A. for attending the interview and joining the appointment.
11. Other conditions of service will be governed by relevant rules and orders issued from time to time.
12. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material, information, he/she will be liable for removal from the service and also such other action as the Government may deem it necessary.
13. *The competent authority reserves the rights to increase or decrease the number of vacancies.*
14. The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Department will issue TDS Certificate/s.
15. The contract appointment is purely temporary and will remain valid up to contractual period for which the engagement is approved on each occasion.
16. The contract appointee will not be eligible to get official accommodation/quarters allotment within the campus as applicable to the other regular employees of this Institute.
17. The contract appointee shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Institute.
18. Canvassing of any kind will lead to disqualification.
19. The contractually engaged person(s) should not have been convicted by any court of law.

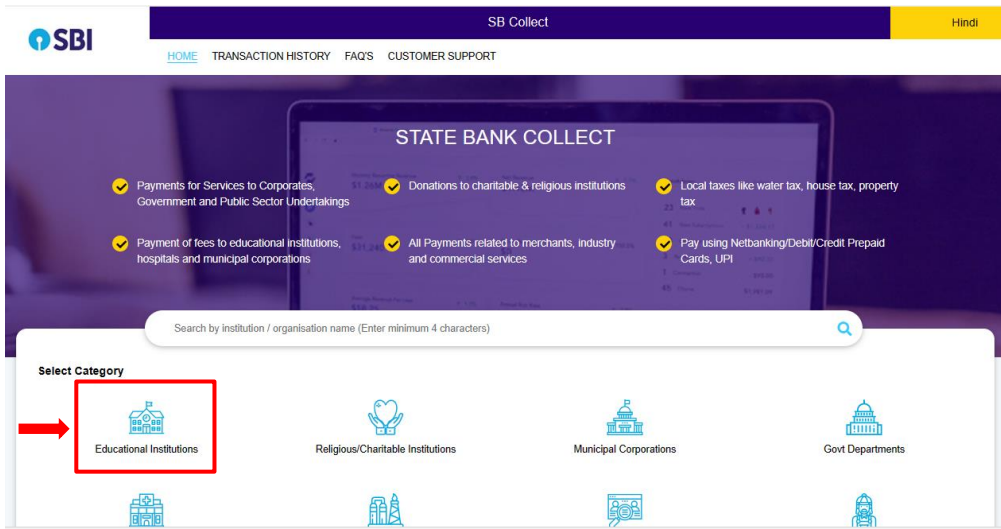
