ADVERTISEMENT FOR APPOINTMENT / ENGAGEMENT OF SPECIAL PUBLIC PROSECUTOR IN CBI, ACB, PUNE TO CONDUCT CBI CASES IN TRIAL COURTS - REGARDING.

- 1. CBI, ACB, Pune intends to create a panel of advocates in 17 districts of Maharashtra State situated under territorial jurisdiction of CBI, ACB, Pune branch, viz., Pune, Satara, Solapur, Sangli, Kolhapur, Nandurbar, Dhule, Jalgaon, Aurangabad, Ahmednagar, Jalna, Beed, Hingoli, Parbhani, Nanded, Latur & Osmanabad. In this regard, applications are invited from the eligible advocates for engagement of Special Public Prosecutor in CBI to conduct CBI cases in Trial Courts.
- 2. PROFESSIONAL FEE The Professional fee of the Advocates will be governed by the terms & conditions contained in DoPT ID No. 225/30/2005-AVD-II dated 20.09.2006 (copy attached).
- 3. **ELIGIBILITY CRITERIA** The following points may be kept in view while submitting the request for the appointment /engagement of CBI Special Public Prosecutors to conduct CBI cases before the Trial Courts:
  - i) Educational Qualification: LLB
  - ii) Enrollment Certificate as an Advocate with the Bar Council.
  - iii) Experience at BAR of handling criminal matters in Sessions Courts.
  - iv) An unconditional willingness/consent to work on the general terms & conditions approved by Government of India from time to time.
  - v) Details of important cases handled by the applicant advocates.
  - vi) A minimum standing of 10 years as an Advocate is required for considering an Advocate for CBI Special Public Prosecutor, who have experience in handling criminal matters.

- 4. PERIOD Minimum 3 years.
- 5. NATURE OF JOB To conduct trial of all the cases pending under trial.
- 6. **DOCUMENTS TO BE SUBMITTED ALONGWITH THE APPLICATION** These following documents may be submitted along with the application:
  - i) Educational Qualifications
  - ii) Enrollment Certificate as an Advocate with the Bar Council.
  - iii) Experience at BAR of handling criminal matters in Sessions Courts.
  - iv) An unconditional willingness/consent to work on the general terms & conditions approved by Government of India from time to time.
  - v) Details of important cases handled by the applicant advocates.

1. F C	for appearance in the trial Court	Rs. 5,000/- (Rupees Five Thousand only) per day
2. D	Prafting fee per pleading	Rs. 1,000/- (Rupees One Thousand only)
3. C	Conference charges	Rs. 200/- (Rupees Two Hundred only) per hour per conference subject to maximum 5 conferences in an individual case/ Group of Cases
4. O	out of pocket expenses	Rs.250/- (Rupees Two Hundred and Fifty only) per case
5. Tı	ravelling Allowance	At the rates as admissible to the Gazetted Officer (Group-A)
