Preference in appointment shall be given to those who have served as Faculty in Medical Colleges/Medical Institutions or in Medical Institutions affiliated with the NBE or in Foreign Medical Teaching Institutions.

Age Limit:

Not exceeding 67 years on the date of Walk-in-Interview.

Note: The crucial date for determining the age limit, work experience and other criteria regarding eligibility for the post shall be the date of interview in the concerned department.

Pay & Allowances:

Honorarium will be paid to the Visiting/Adjunct Faculty as under:

Scope of Work:

Visiting/Adjunct Faculty will be assigned teaching responsibilities. He/she should conduct at least 4 sessions in a month, such as theory, small group discussions, practical's, community based sessions or clinical/bed-side teaching sessions, etc., with each session of not less than 3 hours' duration.

He/she shall not be involved in the routine administrative work of the department and shall not replace the roles and responsibilities of the full-time faculty in the department. Six monthly feedback on teaching by the him/her will be obtained and assessed by this hospital.

Terms of Contract:

- 1) Selected candidate shall be appointed on purely contractual basis for a period of one year. The same can be extended by the Competent Authority of this hospital for another one year, based on the performance of the candidate and the feedback given by the students.
- 2) The engagement shall not confer any right or preference for regular engagement.
- 3) The contractual engagement may be terminated / discontinued on either side giving one month prior notice or one month salary in lieu of notice to this effect without assigning any reason.
- 4) No TA/DA will be paid to candidates for appearing in the walk-in-interview or joining.
- 5) Hostel accommodation/quarters will not be provided.
- 6) Candidate in the Government Service should submit "No Objection Certificate from the employer at the time of Interview".
- 7) The candidates who are already employed must produce relieving order from the previous employer at the time of joining.
- 8) Canvassing of any kind will lead to disqualification.
- 9) The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 10) The candidate should not have been convicted by any Court of Law.
- 11) The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 12) The offer will be issued based on the recommendation of the selection committee on consideration of the relevant factors relating to the functional requirement of the consideration.
- 13) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- 14) In case, any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to his/her appointment, he/she will be liable to be removed/terminated from the service and any action taken as deemed fit by the appointing authority.
- 15) Appointment of selected candidates is subject to his/her being declared medically fit by competent Medical Board of the institute.
- 16) In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/withdraw/cancel any communication made to the candidate.
- 17) No claim for any service benefits like PF, Pension, Gratuity, Medical Allowances, Medical benefits, Seniority, Promotion etc. shall be admissible.

Important Instructions:

- 1. All the candidates are requested to appear for document verification along with filled application form as attached within the scheduled time. Only those candidates whose documents are verified will be allowed to attend Walk-in Interview.
- 2. The Competent Authority have reserves the right to vary these vacancies including increase/decrease/cancellation of filling up of any or full without assigning any reason.
- 3. Change in date of interview, etc, if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information relating to the recruitment. Other terms and conditions are as mentioned above.
- 4. The research publications are not mandatory for retired/resigned/voluntarily retired from Government or other Medical Colleges in case of their re-engagement on the same designation.
- 5. The post advertised can be upgraded/downgraded depending upon the vacancy/functional requirement.

Selection Procedure:

- 1) The selection will be made on the basis of performance of the candidate in interview before the Selection Board.
- 2) Result will be displayed on website only.
- 3) Selected candidates will have to join immediately after receipt of the offer of appointment.

General Instructions:

- 1) Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time.
- 2) Application should be submitted in the prescribed format only. The applications submitted in any other format OR incomplete applications will be summarily rejected.
