Engagement of Paramedical Specialist (Physiotherapy) on Part-time / visit basis for Industrial Health Centre (IHC), HAL, Koraput Division

3. TENURE OF ENGAGEMENT TENURE:

The initial engagement will be for a period of 2 (Two) years. Further, extension of engagement may be considered based on performance of the Part time Paramedical Specialist (Physiotherapy) and requirement of the Division.

4. TERMS & CONDITIONS OF ENGAGEMENT

- (i) The engagement of Part-time Paramedical Specialist will be purely temporary and will not confer any right to claim the status of a regular employee of the Company under any circumstances.
- (ii) The Part-time Paramedical Specialist will not be entitled for any other Allowance or Benefits other than those indicated above.
- (iii) The Part-time Paramedical Specialist will abide by the Company Rules & Regulations governing their engagement.
- (iv) The Part-time Paramedical Specialist will safeguard the security and confidentiality of all official matters and secrecy of information coming to their knowledge.
- (v) The Part-time Paramedical Specialist will be covered under the Income Tax, Service Tax, Professional Tax etc. as per the applicable rules. All such Taxes would be deducted from the remuneration payable to them.
- (vi) Part-time Paramedical Specialist are required to visit the IHC of HAL Koraput on suitable days, as per the requirements of the Organisation for providing treatment to the patients, on intimation from CoMS. The Part-time Paramedical Specialist may be requested to attend emergencies at the IHC, HAL Koraput Division.
- (vii) The engagement of the Part-time Paramedical Specialist (Specialist Doctor) will stand automatically terminated on completion of the prescribed tenure as specified in the Engagement letter. The engagement of Part-time Paramedical Specialist (Specialist Doctor) can be terminated even earlier, with one month notice in writing by either side or payment (consolidated remuneration equivalent to the amount payable for 7 visits) in lieu of notice.

5. HOW TO APPLY:

- (i) Interested candidates shall forward the duly filled-in applications in the prescribed format in A4 size paper, either by post or by email to recruitment.koraput@hal-india.co.in.
- (ii) The applications shall be forwarded along with copies of the documents/certificates in proof of age, Educational Qualification, the marks secured in the qualifying examinations, Post Qualification Experience, valid registration to medical practice and other relevant documents, if any,
- (iii) The applications along with the documents as mentioned above shall reach us either by post or by email on or before **06-04-2024**.

6. SELECTION PROCEDURE:

- (i) Only shortlisted candidates will be called for Personal Interview. The schedule of interview will be intimated to the shortlisted candidates via Email only.
- (ii) Candidates are required to produce the relevant certificates / documents in original at the time of attending interview.
- (iii) The interviews may be conducted in person or virtually over video conference mode. Candidates shall make necessary arrangements accordingly for attending interview.

7. GENERAL CONDITIONS:

- (ii) The Educational Qualifications must be recognized by the Medical Council of India (MCI) or State Medical Council (or) Central Council of Physiotherapy India (CCP India), as the case may be.
