NOTICE

Sub:- Walk-in-Interview for engagement of 02 General duty Medical Officers as full time Contract Medical Practitioners(CMPs) over MB Divl. of Northern Railway.

Moradabad Division of Northern Railway intends to engage 02 (UR-01 & SC-01) General Duty Medical Officers as full time Contract Medical Practitioners(CMPs) on contract basis for a duration of one year through a **Walk-in-interview** to be held from **Open Market and from Retired Doctors of Railways, State & Central Government** who fulfill the all eligibility criteria and term conditions specified as shown below:-

Percentage of reservation between UR, SC, ST and OBC as per recruitment rules will be maintained.

For CMP from Open Market :- The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis by giving at least one week's break from the expiry of each term, subject to extension of delegation of power to DRM beyond one year, **not extendable beyond 12 terms or up to 65 years of age or till such time Doctors selected by UPSC become available, whichever is earlier.**

For CMP Retired Doctors of Railways, State & Central Government :- The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis by giving at least one week's break from the expiry of each term, subject to extension of delegation of power to DRM beyond one year, **not extendable beyond 07 terms or up to 67 years of age or till such time Doctors selected by UPSC become available, whichever is earlier.**

NOTE:- (01) Offer will be on the basis of vacancies available at the time of engagement. **Depending upon administrative exigencies, Rly administration reserve the right to modify no of vacancies and station of posting.** Post may be kept unfilled at the discretion of administration.

(02) Termination of contract :- Contract can be terminated by the Railway Administration at any time during the contract period by giving 15 days prior notice without assigning any reason as per terms and condition laid down vide Railway Board's letter NO:- 96/E(GR)II/9/16 dated 23-02-2000 and NO. 2008/E(GR)II/1/1 dated 16-07-2012. Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated. During the validity of contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 day's notice to Railway Administration.

(03) CMPs who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as full time CMP is a stop gap arrangement and will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.

Date , Time and Venue of Walk-in-Interview & Medical Examination

The Interested Candidates may appear in Walk-in-Interview followed by Medical Examination at the following venue.

Note :- (01) Candidate should submit their Application in duplicate on prescribed Proforma enclosed herewith latest by 11-00AM at above mentioned venue on the day of walk-in-Interview only in person. Thereafter no application will be entertained.

(02) Medical examination will be held after walk in Interview.

(03) Interview may be continued on the next day if not completed on the assigned date.



REMUNERATION:- Remuneration will be as under:-

Note:- (01) For Retired Doctors of Railways, State & Central Government subject to the condition that the remuneration plus pension should not be exceeded the last pay drawn.

(02) If Railway accommodation is provided, deduction will be made from the monthly remuneration equivalent to HRA payable on minimum pay to Junior Scale Officer (Level-10 in 7th CPC) and fixed license fee for accommodation.

Age Limit:-

(01) For Open Market :- Entry level age limit of candidates for appointment as CMP is not exceeding 53 years as on the date of this notification. However age relaxation of 5 yrs in case of SC/ST/Ex. serviceman candidates and 3 years for OBC Candidates is admissible.

(02) Age Limit for Retired Railway Doctors and Central/State Govt Retired Doctors:- Candidates should not have completed more than 65 years of age as on the date of this notification.

Joining of the selected candidates :- After approval of panel by competent authority the panel will be published, notified and intimated through Text message/E-mail/WhatsApp. **The offer of engagement will be issued in favour of selected candidates. The selected candidates have to join as per date mentioned in offer of appointment letter. The candidates who do not report on the assigned date and time will forfeit their chance of contract engagement and such opportunity will be offered to the next empanelled/waitlisted candidates**

Other terms & conditions: -

- (01) The CMP engaged on contract basis will not be allowed private Practice
- (02) The CMP will not be entitled for Railway Quarter as a matter of right
- (03) Candidate, if working, NOC from current employer is to be produced with the application at the time of interview.
- (04) No private practice or any other employment will be permitted during the period of contract.
- (05) No TA/DA/Accommodation and conveyance charges shall be paid for appearing in walk-in-interview.
- (06) At the time of entering into contract, the CMP shall produce certificate of his/her character and antecedents from two Gazetted officers of Central/state Government.
- (07) The willing candidates should bring their Application form in two copies in the prescribed format along with all original and self attested copies of certificates/ testimonials with two Passport size photographs at the time of Walk-in-interview.

The decision of railway administration in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection and allotment of posts to selected candidates will be final and binding on the candidates and No enquiry or correspondence will be entertained in this connection.

In the event of any wrong information, fake certificates/testimonials etc. for securing eligibility are submitted by the candidates, shall be liable for rejection of his/her candidature for the particular post of CMP for which he/she has applied and the candidate shall be liable to be taken up under Govt. of India's law, in force.
