### ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONER ON FULL-TIME BASIS

A walk-in-interview will be held from Open Market and from Retired Doctors of Railways, State & Central Government and PSUs for selection of 06 full time Medical Practitioners over Firozpur Division/Northern Railway on Contract basis for doctors for duration of one year who fulfils the eligibility criteria specified below.

**For Engagement of doctors (CMP) from Open Market:-**The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, not extendable beyond 12 terms or attaining the age of 65 years or till such time Doctors selected by UPSC become available, whichever is earlier as per administrative requirement on the basis of assessment of performance of CMPs.

**For Contract Medical Practitioner from Retired Doctors of Railways & Central/State Government and PSUs:-**

The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, not extendable beyond 07 terms or attaining the age of 67 years or till such time Doctors selected by UPSC become available, whichever is earlier as per administrative requirement on the basis of assessment of performance of CMPs.

Percentage of reservation between UR, SC, ST & OBC as per recruitment rules will be maintained.

### Note:-

1. General Duty CMP will be engaged in case Specialists do not appear for Walk in Interview.
2. Depending on administrative exigencies, railway administration reserves the right to modify number of vacancies and station of posting.
3. Contract can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Board's letter No. 96/E(GR)II/9/16 dated 23.02.2000 and No. 2008/E(GR)II/1/ dated 16.07.2012.
4. CMPs that enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as full-time contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.
5. Eligible SC/ST/OBC candidates may apply along with necessary caste certificate. OBC candidates have to submit certificate in Central Government format to the effect that they do not belong to Creamy layer, from the appropriate authorities.

### (B) Age:-

#### 1) Age limit for Open Market:-

1. Candidates should not have completed 53 years of age as on 01.04.2024 for appointment as Contract Medical Practitioners (CMPs). However, age relaxation of 05 years SC/ST and 03 years for OBC candidates is applicable.
2. From open market, a CMP can be engaged for a maximum of 12 annual terms or upto the age of 65 years, whichever is earlier.

#### 2) Age limit for retired Railway/Government doctors engaged as CMPs:-

1. The number of annual terms of engagement of Retired/Government doctors engaged as CMPs is SEVEN subject to attaining the age limit of 67 years, whichever is earlier.

### (C) Educational/Professional Qualification:-

1. Degree in Medicine i.e. MBBS recognized by the Medical Council of India.
2. A Post Graduate qualification/DNB/DMRD in the relevant subject/field recognized by the Medical Council of India.
3. Three years experience in Clinical work after Post Graduation in the specialty concerned as on the date of interview is desirable.

**(D) Remuneration:-**

**For Medical Practitioners on Contract basis (CMPs):-**

The monthly remuneration payable to CMPs engaged on full time basis on Railways is as under:-

If govt. accommodation is provided, an amount equivalent to House Rent Allowance payable to a fresh entrant to Group-A Jr. Scale and license fee of Railway accommodation so provided shall be deducted from the monthly remuneration payable to the CMPs.

**For Retired Railway/Government doctors engaged as CMPs:-**

The monthly remuneration payable to retired Railway/Government doctors engaged as CMPs on full time basis on Railways is as under:-

Consolidated remuneration as above will be admissible (subject to the condition that remuneration + pension drawn should not exceed the last pay drawn), if Govt. accommodation is not provided. If Govt. accommodation is provided, an amount equivalent to House Rest Allowance payable to a fresh entrant to Group-A Jr. Scale and license fee of Railway accommodation so provided shall be deducted from the monthly remuneration payable to the CMP.

- (E) Doctors serving under State/Central Government/Public Sector undertaking etc. may apply with 'NOC' from the respective organizations.
- (F) Doctors while applying should indicate past service rendered, if any, including the period of contract put in by them on all over Indian Railways.
- (G) Those fulfilling the above conditions and interested candidates can appear in walk-in-interview followed by Medical examination at following venue for all of the above posts:-

**Note:-**

1. Candidates should submit their application on prescribed Performa enclosed herewith latest by 10.00 AM at above mentioned venue on the day of walk-in-interview.
2. The doctor so engaged on contract basis will not be allowed for private practice.
3. The contract doctor shall not be entitled for Railway quarter etc as a matter of right.
4. Candidates should bring their application form along with original, attested copies of all educational certificates & mark-sheets, experience certificate, Caste Certificate (SC/ST/OBC Candidates), Retired Doctors will bring a copy of their Pension Payment order (PPO).
5. No TA/DA is admissible.
6. He/she shall also have to carry out general duties as and when required by railway administration in addition to their specialized work.
7. Suitable candidates will be intimated through telephone call or SMS to report at concerned posting place for medical and joining. The candidates who do not report at the assigned date and time will forfeit their chance of contract engagement and such engagement will be offered to the next empanelled candidate.
8. Medical examination of the selected candidates will be held after giving offer of appointment.
