The Patna High Court proposes to launch the Digital Law Reports on the Patna High Court Website for the purpose of publishing the Patna High Court Judgments, having Neutral Citation and other Judgments with Head-Notes in English and Hindi which would facilitate young Lawyers, who are unable to pay for high priced law journals, Law Students, Law Professors and common citizen to acquaint themselves with the law. Litigants will also be in a position to understand the judgments. Therefore, the Patna High Court invites online applications from persons having experience of 3-5 years of preparing Headnotes in Hindi/ English with reputed Law Journals/ Publishers as well as from retired Judicial Officers, Lawyers, retired and serving Assistant Public Prosecutors, retired and serving Law Professors, for engagement as "Reporter" with the Patna High Court, Patna for a period of 05 years for preparation of Headnotes for the Judgments as may be given by the Patna High Court, under the terms and conditions as mentioned below :-

Number of posts	10 (Ten)
Minimum Qualification/ Eligibility Condition	Experience of 3-5 years of preparing Headnotes in Hindi/ English with reputed Law Journals/ Publishers. Preference will be given to persons having higher experience. Retired Judicial Officers, Lawyers, retired and serving Assistant Public Prosecutors, retired and serving Law Professors shall also be eligible for this engagement.
Age Limit	No Limit
Remuneration	₹500/- (Rupees Five Hundred Only) per Judgment.
Tenure of engagement	Purely on short term engagement basis initially for a period of 05 (Five) years.
Mode of Selection	The eligible candidates shall be shortlisted through Interview. No T.A. will be paid for appearing in the interview.
Other terms and conditions	(i) The engagement would be purely a short term engagement, as aforesaid. It would give no right to the persons to claim permanent employment on any post in the High Court. (ii) Engagement may be terminated without assigning any reason at any time during the tenure of engagement by the High Court without prior notice.

Willing candidates who meet the abovementioned criteria may apply online through the link provided on the official website i.e. [www.patnahighcourt.gov.in](http://www.patnahighcourt.gov.in) only. The link shall remain active from 10.04.2024 to 20.04.2024. Any application submitted through any other mode or upon expiry of the stipulated period shall not be accepted.

Application once submitted successfully cannot be changed/ altered and no communication in this regard shall be entertained. Therefore, the candidates must check the correctness of the particulars they fill before finally submitting the application form. A copy of the successfully submitted application form is required to be retained by the candidates.
