2. 3. Resignation: One- m o n t h advance notice shall be required before seeking resignation from RVNL.

4. The responsibility to establish eligibility for the post applied for with reference to all the prescribed eligibility conditions rests with the applicant.

5. Remuneration: Monthly remuneration is negotiable based on educational qualification and experience in the relevant field. The candidate should produce, last three pay slips for deciding the remuneration.

6. Other Instructions:

a) Candidates currently serving in Govt/Quasi Govt. offices/Public Sector Undertakings shall have to submit "No Objection Certificate" from their employer at the time of walk in interview, failing which they shall not be allowed to appear in walk in interview and their candidatures shall be treated as cancelled.
