TERMS & CONDITIONS:

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. - 2. Tenure: The assignments are purely on a contract basis for a period of 6 months (which can be extended to a maximum of 3 years). These Appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Kalyani/DHR or continued contractual appointment.
- 3. Expiry of Contract: The contract will automatically expire on completion of the stipulated time or earlier in case of withdrawal of support by the funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
