**Vacancy Circular No. 01/2024**

Applications are invited from eligible officials working in Government to fill up the following posts on deputation/absorption basis in the office of the Competent Authority and Administrator, (SAFEMA/NDPSA) & Adjudicating Authority, PBPTA, Delhi: -

1. **Inspector** :- 01(One) an existing vacancy required to be filled up by deputation or absorption basis in the pay level-6 of the pay matrix Rs.35400-112400/- 7th CPC, GCS, Group 'C', Non Gazetted, Ministerial (pre-revised in PB-2 of Rs. 9300-34800/- with GP Rs. 4200/-,6th CPC).

Eligibility: -

- (i) Inspector of Income Tax or Customs and Central Excise or Narcotics (Central Bureau of Narcotics or Narcotics Control Bureau) or Assistant Enforcement Officer or Sub-Inspector of Police, Central Bureau of Investigation; or
- (ii) Head Clerks or Tax Assistants or Upper Division Clerks of Income Tax, Central Excise and Customs Departments who have qualified in the Departmental Examination for promotion to the grade of Inspector in the respective Departments Officials with flair for Income- Tax Act, Customs Act, FEMA and Narcotic Drugs and Psychotropic Substances Act will be given preference.

2. **Assistant** : - 01(one) anticipated vacancy required to be filled up by deputation basis in the pay level-6 of the pay matrix Rs.35400-112400/- 7th CPC, GCS, Group 'C', Non-Gazetted, Ministerial (pre-Revised in PB-2 of Rs. 9300-34800/- with GP Rs. 4200/-,6th CPC).

Officers of the Central or State Government Departments or Organizations.


- (i) Holding analogous post; or
- (ii) Upper Division Clerk of the Central or State Government Departments or Organization and of Income Tax or Central Excise or Customs Commissionerate or Directorates or Narcotics in the pay scale of Rs. 5200/- - 20200/- + Grade Pay Rs. 2400/- with 8 years' service in the grade.

**NOTE: -**

The period of deputation including the period of deputation in another ex- cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date of receipt of applications.

Officers once selected for the above posts will not be ordinarily allowed to opt out without a valid reason accepted by the Head of the Department.
