In this regard, applications are invited from the eligible advocates for engagement as Special Public Prosecutors (Retainer Counsels) in CBI to conduct the Prosecution, Appeals, Revisions and other matters arising out of the cases investigated by CBI or related to the CBI in the Delhi High Court.
2. **PROFESSIONAL FEE:** Counsel fee/Professional fee of the Advocates engaged as Special Public Prosecutor (Retainer Counsel) will be governed by the terms and conditions contained in DoPT letter No. 225/18/2023-AVD-II dated 24.01.2024 (copy enclosed).
3. **ELIGIBILITY CRITERIA:** The following eligibility criteria may be considered carefully by the applicant while submitting the application for the appointment/engagement of CBI, Special Public Prosecutor (Retainer Counsel) to conduct the Prosecution, Appeals, Revisions and other matters arising out of the cases investigated by CBI or related to the CBI in the Delhi High Court
  - i. Education qualification: LLB
  - ii. Enrolment Certificate as an Advocate with the Bar Councils.

- iii. Experience at BAR of handling criminal matters in the Courts including the High Courts.
- iv. An unconditional willingness / consent to work on the general terms and conditions approved by the Govt. of India from time to time.
- v. A minimum experience of 10 years as an Advocate with experience in handling in criminal matters.

4. **PERIOD:** Minimum 03 years

5. **NATURE OF JOB:** To conduct the Prosecution, Appeals, Revisions and other matters arising out of the cases investigated by CBI or related to CBI in the Delhi High Court.

6. **DOCUMENTS TO BE SUBMITTED ALONGWITH THE APPLICATION:** Following documents are required to be submitted along with the application:



	(ii) For cities other than Delhi, Mumbai, Kolkata and Chennai	Rs. 10,000/-
3	Drafting fee per case for drafting, pleading, reply to petitions, ground of appeals etc.	Rs. 5000/-
(iv)	Clerkage in a case or batch of cases irrespective of number of hearings	10% of daily fee, subject to maximum of Rs. 3000/-
(v)	Out of pocket expenses in a case or batch of cases (till its final disposal payable on the bills)	Rs. 1000/-
