General Terms and conditions for SR/PTS/FTS

1. The number of vacancies may be changed without any prior notice.
2. No TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
3. The Competent Authority reserves the right to fill up all or not to fill up any post.
4. Selected candidates will have no claim for regularization of the service in the hospital.
5. Hostel accommodation/quarters/uniform will not be provided.
6. The selected candidate (For Full time Specialist/Part time Specialist & Senior Resident three year) will have to furnish a DD/Bankers Cheque for an amount of Rs. 30,000/- (Rupees Thirty Thousand Only) drawn in favour of 'ESIC Fund A/c No 1' payable at Ahmedabad, towards security deposit.
7. The contractual engagement may be terminated/discontinued on either side giving one month prior notice to this office without assigning reason.
8. The appointment shall not offer any right or preference for regulate appointment.
9. In case, regular candidate joins the post, the appointment shall be terminated with immediate effect as per the condition of the contract.
10. Private practice (for SR) is strictly not allowed. If found guilty, suitable action as provided under the relevant rules shall be taken.
11. No claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, Promotion and leave will be admissible.
12. Candidates must be registered with Gujarat Medial Council or MCI before joining the post.
13. The candidate who is in the Government Service should submit "No Objection Certificate" from the employer at the time of interview.
14. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. They should also be in possession of the required certificates in the prescribed format in support of their claim as stipulated in this Notice. OBC (Non-creamy layer) candidates should ensure that they are in possession of valid OBC Certificate issued within the due date issued by the authority in the format of certificate to be produced by other backward classes applying for appointment to posts under the Government of India.

failing which the benefit of reservation / relaxation will not be given or their application shall be rejected and no request/ correspondence will be entertained. Certificates issued in other format will not be accepted and the candidates will be treated as “General Category” for all purpose.

16. Candidates claiming reservation under EWS category should produce their EWS certificate as prescribed vide DoPT, Govt of India OM No. 36039/1/2019-Estt.(Res) dated 31.01.2019.
17. The candidates are advised to bring their application/Bio data and original certificates with one set of photocopies of the certificates.
18. The decision of the selection board will be final on all aspects of selection and no further correspondence will be entertained under any circumstance.
19. The tenure is for a maximum period of tenure is One year for Senior Resident or till the regular incumbent joins whichever is earlier, which could be further extended for further up to two (2) years with the approval of Medical Superintendent, subject to satisfactory performance.
20. The candidates shall be governed by the relevant Rules and Regulations adopted by the ESIC in this regard.
21. Candidates who have already completed Senior Residency for 3 years are not eligible again for Senior Resident post.
