Kochi Metro Rail Limited (KMRL) a 50:50 Joint Venture of Government of India and Government of Kerala incorporated for the implementation of the Kochi Metro Rail project in Kochi and for its operation & Maintenance intends to appoint the following official:-

Duration of Appointment : The appointment will be on Deputation/ contract basis for a

period of 5 years, or up to the date of superannuation,

whichever is earlier.

1. Job description and responsibilities

The incumbent shall be a member of the Board of Directors of KMRL and will report to the Managing Director of the Company.

He/ she will be responsible for all Finance related work in KMRL. He/ she will be the overall in-charge of Finance, Accounts, Audit functions and fund management of the organization and shall be responsible for –

- a) Improving and implementing a comprehensive financial management plan
- b) Providing operational oversight from finance/ accounts angle for overall project implementation
- c) Coordinating the consolidation of the annual, short and long term financial plans, budgets, forecasts; preparing, analyzing and reporting the results to the management
- d) Optimizing deployment and ensuring adequacy of financial resources during the implementation of the project
- e) Appraisal of financial risks and remedial actions
- f) Coordination with Govt. of India, Govt. of Kerala, financial institutions in India and overseas.

He/ she shall also may have to oversee and supervise some other general administration functions of KMRL.

*MBA / Equivalent must be a full time 2-year course, from a University / Institute recognized by the UGC / Accreditation body. **Preference would be given to Chartered Accountants.**

Officers of organized Group A Accounts Services (i.e. Indian Audit & Accounts Service, Indian Defence Accounts Service, Indian Railways Accounts Service, Indian Civil Accounts service, Indian P &T Accounts & Finance Service and Indian Cost Accounts Service)

(III) Work Experience (To be reckoned as on 01.10.2024)

- (1) At least 25 (Twenty-Five) years post qualification experience in Project Finance/ Finance and Accounts/ Audit/ setting up Financial, Accounting and Audit systems and procedures in a large public or private sector organizations of repute. Candidate should have knowledge and experience in managing financial and accounting software.
- (2) Candidate should be well versed with the latest accounting standards including GAAP, as well as developments related to IFRS, taxation, investment and portfolio management, raising of funds, tendering and contracting.
- (3) Should have proven ability to handle related functions independently and lead a team of finance & accounting.
- (4) Individuals with experience and knowledge in securing funds from external agencies and its management will be preferred.

(IV) Required Professional Experience and minimum requirements on the scale of pay: (To be reckoned as on 01.10.2024)

A. Applicant from Govt. Organizations

Should be Member of Group "A" Accounts Service of Government of India with overall 25 years of post – qualification work experience as mentioned above.

Officers should have worked at least for a period of 2 years in the level 14 of the 7th CPC or Senior Administrative Grade (SAG) (with Grade Pay of Rs.10000 in Pay Band 4 of CDA Grade of Rs. 37400-67000 (pre-revised) or higher

B. Applicant from PSUs:

Should have overall 25 years of post - qualification work experience as mentioned above.

Should have worked at least 2 years in the pay scale of Rs. 120000 – 280000 or Rs 51300-73000 (Pre-revised IDA) or higher.

C. Applicant from Private Sector:

Should have overall 25 years of post -qualification work experience as mentioned above.

Should have worked in companies where the project size of not less than Rs 1000 Crore or a company with an annual turnover of not less than Rs 500 Crore in the last 3 years for which the documentary proof of company's Project size / turnover to be attached along with experience proof.

In the preceding 7 years, should have worked at least 5 years in a level reporting directly to a Director on the Board i.e. one level below Board level with last drawn minimum CTC of Rs.36.00 lakhs per annum. Proof of Organizational hierarchy, depicting the same should be attached along with payslips/IT returns for proof of CTC.

(V) Knowledge and Expertise

- (1) Candidate should have knowledge and experience in managing financial and accounting software.
- (2) Candidate should be well versed with the latest accounting standards including GAAP, as well as developments related to IFRS, taxation, investment and portfolio management, raising of funds, tendering and contracting.
- (3) Should have proven ability to handle related functions independently and lead a team of finance & accounting.
- (4) Individuals with experience and knowledge in securing funds from external agencies and its management will be preferred.
