Maharashtra Metro Rail Corporation Limited (MMRCL), a joint venture company with equal participation from Government of India and Government of Maharashtra is implementing Pune Metro Rail Project, Nagpur Metro Rail Project and Navi Mumbai Metro Line-1 in the State of Maharashtra.

1. The Maharashtra Metro Rail Corporation Ltd. (MMRCL) is issuing this notification for enrolment of Interns.

2. Who Can Apply:

(i) For **Mandatory in Curriculum**:

Graduate / Post Graduate students of Engineering & Management Colleges. Engineering students from Colleges recognized by AICTE or UGC in Civil/ Mechanical/ Electrical/Electronics/ Computer/ IT/ Electronics & Telecommunication, Intelligent Transport System / Railway Engineering disciplines, Graduate students from Journalism, Legal and Post Graduate Management students from Human Resources / Finance/ Marketing / Operations & Business Analytics.

(ii) For **Targeted by MMRCL (UG Engineering)**:

Final year students from Premier Engineering Institutes, IITs/COEP/VNIT/VJIT/SPCOE/Gati Shakti Vishwavidyalaya/Walchand COE of Civil/Mechanical/Electrical/Electronics/Computer/IT/Electronics&Telecommunication, Intelligent Transport System/Railway Engineering disciplines.

(iii) For Targeted by MMRCL (PG Engineering & Management):

Final Year M.Tech students from IITs/COEP/VNIT/VJIT/SPCOE /Walchand COE of Civil / Mechanical / Electrical / Electronics / Computer/IT/Electronics & Telecommunication, Intelligent Transport System / Railway Engineering and Post Graduate students from IIMs Management programme in Human Resources / Finance / Marketing/Operations & Business Analytics.

The candidates should attach bonafide certificate issued by the concerned Institute to pursue Internship. In case of non-submission of bonafide certificate, candidate will not be eligible for further selection process.

3. The candidates selected for Internship will be paid allowance as mentioned below:

- 4. **Selection:** MMRCL shall examine Applications received online as per the eligibility criteria notified and do the shortlisting on merit basis of all previous semester marks obtained in Engineering in case of UG students and marks obtained in Graduation in case of PG students. Only shortlisted candidates will be called for interview. In order to regulate the number of candidates to be called for interview, if so required, the Management reserves the right to relax the minimum eligibility standards / criteria for selection of suitable candidates depending upon the response. The selection will be based on the marks secured in academics and qualifying interview.
- 5. The selected candidates will undergo internship in MMRCL for a period of 2 to 6 months. The internship certificate will be awarded to the interns upon satisfactory completion of their internship and on submission of project report. In the event of discontinuation during the middle of the internship period, no certificate will be issued to the candidate under any circumstances.

6. General Conditions: -

- MMRCL reserves the right to cancel this notification at any stage without assigning any reason whatsoever.
- In case of any dis-obedience/misbehaviour/misconduct by the intern, he/she will be sent back immediately to the concerned College/Institute/University.
- During Internship, the intern shall carry out the assignment entrusted to him/her; strict confidentiality to be maintained for the same. Interns

should not share confidential information about MMRCL works to third parties.

- Acceptance or Rejection of application of the candidates will be at the sole discretion of the management. Incomplete applications, without Bonafide certificate and Mark Sheet from Institute, will be summarily rejected.
- A recent photograph and signature of the candidate are to be uploaded while submitting application.
- Verification of qualification etc. will be done at the time of selection/document verification.
