# Eligibility conditions for the post of Assistant Civil Engineer for Transfer on deputation.

Applications for one post of Assistant Civil Engineer to be posted at Mumbai in the grade Pay of Rs.4600/-, Level-7 as per 7<sup>th</sup> CPC are invited on transfer on Deputation (including short term contract) basis from Officers under the Central Government.

## Education & Other Qualifications required:-

- (i) holding analogous posts on regular basis and possessing degree/diploma in Civil Engineering from a recognized University or equivalent; or
- (ii) holding posts in the scale of Rs.1640-2900(IV Pay Commission) corresponding to Level-6(Pay Band-2) Rs 9300-34800/- with Grade pay of Rs.4200/- or equivalent on regular basis and possessing degree in Civil Engineering from a recognized University or equivalent; or
- (iii) with three years' regular service in posts in the scale of Rs.1640-2900 (IV Pay Commission) corresponding to Level-6 (Pay Band-2) Rs 9300-34800/with Grade pay of Rs.4200/- or equivalent and possessing diploma in Civil Engineering from a recognized University or equivalent; or
- (iv) with 5/8 years' regular service in posts in the scale of Rs.1400-2300/2600(IV Pay Commission) corresponding to Level-6 (Pay Band-2) Rs 9300-34800/with Grade pay of Rs.4200/- and possessing degree/diploma in Civil Engineering from a recognized University or equivalent.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment by transfer on deputation shall be not exceeding 56 years as on the closing date of receipt of applications.)
