**ENGAGEMENT OF CONSULTANT**

CBI ACB Mumbai intends to hire 01 retired police officer(s)/official(s) from Central Police Organisation(s) / State Police as consultant for pairvi work in trial court(s) located at Mumbai as per the enclosed terms & conditions as laid down in OM No. 3-25/2020-EIIIA of Ministry of Finance (Dept. of Expenditure) dated 09.12.2020.

2. Eligible retired officers, having good health and willing to work as pairvi officer on contractual basis may submit their applications within due date along with a copy of PPO, LPC/last salary slip/APARS of last 05 years.

3. The eligibility criteria for appointment of consultant (pairvi officer) on contract basis are as under:

- (i) Retired Police Officers / Officials of the Central Police Organisation / State Police.
- (ii) The officers / officials should not have completed more than 04 years after his/her superannuation from government service.
- (iii) Minimum 03 years experience in investigation/prosecution/court duty during trial of criminal cases.

4. Remuneration payable to consultants:

- (i) A fixed monthly amount shall be admissible arrived at by deducting the basic pension (without commutation, if any) from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment / percentage increase during the contract period.
- (ii) While fixing remuneration in case of Central / State Government retirees covered under the National Pension System (NPS), an amount equivalent to 30% of the last basic pay as drawn at

the time of retirement shall be deducted from the last basic pay and the resultant amount shall be the fixed monthly amount as remuneration (DOPT OM dated 18.10.23).

(iii) No increment and dearness allowance shall be allowed during the term of the contract..

5. Other entitlement of Consultants:

(i) **Leave:-** Paid leave of absence shall be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year shall not be allowed.

(ii) **Tax Deduction at Source:-** TDS/applicable taxes as admissible shall be deducted from the monthly remuneration of Consultants. A TDS certificate shall be issued by the concerned DDO on demand.

(iii) **TA/DA:-** No TA/DA shall be admissible for joining the assignment or on its completion. The consultants would be entitled to draw TA/DA for work-related travel as per his/her last entitlement at the time of retirement as per the Government norms, in case he/she is deputed for official work outside headquarters.

(iv) **Accommodation/HRA:-** No accommodation / HRA shall be provided.

(v) **Transportation Allowance:-** An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment.
