GENERAL INSTRUCTIONS TO CANDIDATES AND MATHOD OF APPLICATION TO APPEAR IN WALK IN INTERVIEW

- 1. The number of vacancies may be changed without any prior notice.
- 2. No TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
- 3. The Competent Authority reserves the right to fill up all or not to fill up any post or cancel any vacancy/interview at any stage.
- 4. The selected candidates will have to join on or before the stipulated date given in offer of appointment.
- 5. The selection is subject to the candidates providing their medical fitness Certificate issued by appropriate competent authority.
- 6. Candidates must be registered with Medial Council of India before joining the post.
- 7. The candidate who is in the Service should submit "No Objection Certificate" from the employer at the time of interview.
